## **RESOLUTION NO. 06-08-2017-01 (FAA LINE EXTENSION)**

# A RESOLUTION OF THE COLLIER TOWNSHIP MUNICIPAL AUTHORITY AGREEING TO ACCEPT OWNERSHIP OF CERTAIN SANITARY SEWERS AND MANHOLES AS INSTALLED AND CONSTRUCTED AS PART OF THE FAA LINE EXTENSION

WHEREAS, the property developer, FAA, has caused to be constructed, certain sanitary sewers, manholes and associated main line components as they were designed to service the FAA site along Nike Site Road; and,

WHEREAS, the FAA awarded the necessary contracts for the construction and installation of the system by and through Bella Enterprises, Inc.; and,

WHEREAS, field observations of construction of sanitary sewers and manholes were performed by NIRA Consulting Engineers, Inc. on behalf of the Collier Township Municipal Authority; and,

WHEREAS, NIRA Consulting Engineers, Inc., has advised the Collier Township Municipal Authority that final inspection and testing of the sanitary sewer lines within the project site are complete; and,

WHEREAS, the sanitary sewer lines and manholes previously have passed the required air and vacuum tests and passed the necessary deflection (mandrel) test; and,

WHEREAS, the following described lines and manholes have now passed the required mandrel testing and the required air testing of the lines and manholes as described in Exhibit A, with all testing being verified and approved by NIRA consulting Engineers; and,

WHEREAS, NIRA Consulting Engineers, Inc. recommended that the sewer lines listed in the attached exhibit sheet be accepted by the Collier Township Municipal Authority; and,

WHEREAS, the FAA. now has provided to the Collier Township Municipal Authority its certification as to the construction cost of the said lines, which were constructed at a construction cost of \$85,460.00; and,

WHEREAS, the FAA had posted the required maintenance bond in the amount of fifteen (15%) percent of the construction costs, which did run for a period of eighteen (18) months from the date of the completion of the work.

NOW THEREFORE, the Collier Township Municipal Authority at a publicly held meeting on the 8th day of June, 2017:

- Reviewed this Resolution, and formally adopted the Resolution, accepting ownership and control of the sanitary sewer lines and manholes listed in the attached exhibit as of the date of this Resolution.
- 2. The lines and manholes hereby accepted are in and through the project area all as shown in as built plans and specifications and all being part of, located in and through as an Authority sanitary sewer system now and into the future.
- 3. This Resolution of acceptance of these public improvements shall be maintained as part of the records of the Collier Township Municipal Authority and a copy shall be delivered to the FAA.
- As part of this acceptance, the FAA has, or is to provide, two (2) sets of As-Built Reproducible Drawings and one (1) DVD electronic copy of the sanitary sewers as accepted.

## SEWER LINES TRANSFERRED BY RESOLUTION 06-08-2017-01

### (FAA LINE EXTENSION ACCEPTANCE DESCRIPTION)

Approximately 1228 lineal feet of 8" SDR-35 PVC Pipe, 69 lineal feet of 8" SDR-26 PVC Pipe, 60 lineal feet of 16" O.D. x 0.250" wall Steel Casing Pipe, and (8) 4-ft. diameter Precast Concrete Manholes as constructed from CTMA manhole TR-99-2B to and including manhole FAA # 7 which is the point of connection of a privately owned and privately maintained lateral serving the FAA facility.
