

AN ORDINANCE PROVIDING FOR AN ADDITIONAL SALES TAX IN THE AMOUNT OF ONE-HALF OF ONE PERCENT FOR THE PURPOSE OF FUNDING STORM WATER CONTROL, LOCAL PARKS AND PARK AND RECREATION FACILITIES AND PROGRAMS; CALLING AN ELECTION ON THE QUESTION OF APPROVING SUCH A SALES TAX; AND MATTERS RELATED THERETO.

WHEREAS, Sections 644.032 and 644.033, R.S.Mo. 2016, authorize cities in Missouri to impose a sales tax of up to one-half of one percent for the purposes of providing funding for storm water control and/or local park functions authorized in the ordinance submitting the tax to the voters; and

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF COOL VALLEY, MISSOURI AS FOLLOWS:

Section 1. Subject to authorization by the voters as hereinafter provided, an additional sales tax in the amount of one-half of one percent is hereby levied on all retail sales in the City of Cool Valley, Missouri, for the purpose of providing funding for storm water control and local parks for the City. Revenue from this tax shall be expended for storm water control projects, local park functions including the purchase, construction, maintenance, repair, improvement, equipment, fixtures, programs and operations of local parks and recreation functions and programs including City recreation facilities.

Section 2. An election is hereby ordered to be held in the City of Cool Valley, Missouri, on April 3, 2018, on the following proposition:

PROPOSITION 1

Shall the City of Cool Valley, Missouri, impose a sales tax of one-half of one percent for the purposes of providing funding for storm water control and local parks and park and recreation facilities and programs?

Section 3. The City Clerk shall prepare and cause to be forwarded to the Board of Election Commissioners of St. Louis County, Missouri, a Notice of

Section 5. This Ordinance shall be in full force and effect from ar
passage by the Board of Aldermen and approval by the Mayor.
