AN ORDINANCE PROVIDING FOR AN ADDITIONAL SALES TAX IN THE AMOUNT OF ONE-HALF OF ONE PERCENT FOR ECONOMIC DEVELOPMENT PURPOSES AND CALLING AN ELECTION ON THE QUESTION OF WHETHER TO IMPOSE SUCH SALES TAX, AND MATTERS RELATED THERETO.

WHEREAS, City of Cool Valley is authorized by Section 67.1305 R.S.Mo., to impose a sales tax at a rate not to exceed one half of one percent for economic development purposes; and

WHEREAS, the Board of Aldermen wishes the enable the voters of the City to determine whether the sales tax so authorized should be levied;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF COOL VALLEY, MISSOURI, AS FOLLOWS:

Section 1. There is hereby levied an additional sales tax in the amount of one half of one percent tax on all retail sales made in the city which are subject to sales tax under Chapter 10 1875. Mo., for economic development purposes

Section 2. Said sales tax shall become effective as provided by law upon approval thereof by a simple majority of the votes cast on the proposition by the qualified voters of the City of Cool Valley voting thereon.

Section 3. An election is hereby ordered to be held in the City of Cool Valley, Missouri, on April 3, 2018, on the following proposition:


Section 4. The City Clerk shall prepare and cause to be forwarded to the Board of Election Commissioners of St. Louis County, Missouri, a Notice of
