Ordinance No. 1194

**AN ORDINANCE AMENDING CHAPTER 115 OF THE MUNICIPAL
CODE OF THE CITY OF COOL VALLEY TO CREATE THE POSITION OF
SPECIAL LIAISON OFFICER.**

WHEREAS, the City of Cool Valley ("City") recently entered into a contract with the City of Normandy for the Normandy Police Department to provide police services within the City of Cool Valley; and

WHEREAS, the Mayor and Board of Aldermen have determined that the City and the Normandy Police Department would benefit from the assistance of an individual with specialized knowledge of public safety issues within the City;

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF COOL VALLEY, MISSOURI, AS FOLLOWS:

Section One

Chapter 115 of the Municipal Code of the City of Cool Valley is hereby amended by the addition of three new sections, initially to be designated as Sections 115.400, 115.405, and 115.410, to read as follows:

TITLE I.	GOVERNMENT CODE
CHAPTER 115.	CITY OFFICIALS
ARTICLE VIII.	SPECIAL LIAISON OFFICER
SECTION 115.400.	SELECTION

The Mayor, with the consent and approval of the majority of the members of the Board of Aldermen, may appoint a Special Liaison Official to assist with certain duties of the Police and other city Departments. The Special Liaison Officer need not be a resident of the City, but shall be a graduate of an accredited police academy and certified in accordance with Chapter 590, RSMo.

SECTION 115.405. DUTIES

The Special Liaison shall be responsible for the following duties:

- a. Review violations of city ordinances as recorded by an Automated Traffic Enforcement System as defined in Section 320.060 of this code;

- b. Serve as balliff in the City's municipal court as requested by either the Mayor or municipal judge;
- c. Assist with code enforcement and housing issues;
- d. Serve as "Director" as designated by Section 500.180 of this Code relating to the registration of vacant properties;
- e. Conduct an annual audit of city property;
- f. Assist the City's Department of Public Works with such duties as may be requested by the Director of Public Works;
- g. Any other such responsibilities as may be assigned from time to time by the Mayor.

SECTION 115.410. COMPENSATION

The Special Liaison Officer shall receive such compensation for performing the duties of that office as shall be fixed by ordinance from time to time.

Section Two

The Chapter, Article, Division and/or Section assignments designated in this Ordinance may be revised and altered by the codification company servicing the City's Code of Ordinances upon supplementation of such code if, in the discretion of the editor, an alternative designation would be more reasonable. In adjusting such designations the editor may also change other designations and numerical assignment of code sections to accommodate such changes.

Section Three

It is hereby declared to be the intention of the Board of Aldermen that the sections, paragraphs, sentences, clauses, phrases and words of this ordinance are severable, and if any section, paragraph, sentence, clause, phrase or word(s) of this ordinance shall be declared unconstitutional or otherwise invalid, such unconstitutionality or invalidity shall not affect any of the remaining sections, paragraphs, sentences, clauses, phrases and words or this ordinance since the same would have been enacted by the Board of Aldermen without the incorporation in this ordinance of any such unconstitutional or invalid portion of the ordinance.


Section Four




