Ordinance No. 1220

**AN ORDINANCE TO AUTHORIZE THE MAYOR TO ENTER INTO A CONTRACT ON BEHALF OF THE CITY OF COOL VALLEY WITH GENERAL CODE CORPORATION TO EXPAND THE CITY'S CODE PUBLICATION.**

**WHEREAS**, § 79.450, RSMo. provides that municipalities of the fourth-class may adopt any ordinance not inconsistent with the laws of the state, as may be expedient for maintaining the peace, good government and welfare of the city and its trade and commerce; and

**WHEREAS**, § 546.902, RSMo. provides that municipalities in St. Louis County, Missouri may adopt any ordinance not inconsistent with the laws of the state, as may be expedient for maintaining the peace, good government and welfare of the city and its trade and commerce; and

**WHEREAS**, § 71.943, RSMo. provides that municipalities can provide for the codification and revision of its ordinances from time to time; and

**WHEREAS**, the City has utilized General Code Corporation to codify its ordinances; and

**WHEREAS**, the Board of Aldermen of the City of Cool Valley desires to increase public access to its ordinances;

**NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF COOL VALLEY, MISSOURI, AS FOLLOWS:**

**Section One**

The Mayor of the City of Cool Valley, Missouri is authorized to enter into an agreement with General Code Corporation to purchase the Standard Code eCode360 package at a price not to exceed \$995.00 per year, subject to the appropriation of sufficient funds on an annual basis, with such terms and conditions to be approved by the City Attorney.

**Section Two**

This Ordinance shall be in full force and effect from and after its passage by the Board of Aldermen.
