

ORDINANCE NO. 24-01

AN ORDINANCE TO AMEND THE CODE OF THE CITY OF CORUNNA, MICHIGAN, CHAPTER 2 – ADMINISTRATION, ARTICLE II. COUNCIL, SECTIONS 31-32, THEREOF.

THE CITY OF CORUNNA, MICHIGAN ORDAINS:

SECTION I. AMENDMENT TO SECTIONS 2-31 thru 2-32, OF THE CITY CODE OF THE CITY OF CORUNNA, MICHIGAN, shall be as follows:

SECTION 2-31 Administration

- a. The mayor and each councilmember shall receive ~~\$20.00~~ **\$60.00** for each regular council meeting, each special council meeting and each committee/commission/board meeting which he shall attend at the request of council.

SECTION 2-32 Maximum Yearly Compensation

- a. Councilmembers. The compensation for each councilmember for meeting attendance shall not exceed ~~\$1,000.00~~ **\$3,000.00** in any fiscal year. **In addition, however, each councilmember shall receive the sum of \$500.00 per fiscal year.**
- b. Mayor. The compensation for the mayor for meeting attendance shall not exceed ~~\$1,000.00~~ **\$3,000.00** in any fiscal year. In addition, however, the mayor shall receive the sum of ~~\$500.00~~ **\$3,000.00** per fiscal year.

SECTION II Severability.

This Ordinance and the several sections, sub-sections, paragraphs, clauses and parts thereof are hereby declared to be severable. If any part or clause thereof is declared or adjudged invalid by present or future legislation or decree, the balance of the Ordinance shall not be affected thereby.

SECTION III Conflicting Ordinances Repealed.

All Ordinances previously adopted and incorporated in the Code of the City of Corunna, Michigan, through codification procedures, or any existing Ordinances that are inconsistent with the provision of this Ordinance are hereby repealed, and in the case of inconsistencies, to the extent of such inconsistency, are hereby repealed.

SECTION IV Copies Available.

This Ordinance may be purchased or inspected in the City Clerk's Offices, Monday through Thursday, between the hours of 9:00 a.m. and 4:30 p.m.

SECTION V Effective Date.

This Ordinance shall take effect November 6, 2024.
