CITY OF COLUMBIA, ILLINOIS ORDINANCE NO. 3565

AN ORDINANCE APPROVING AN ANNEXATION AGREEMENT FOR PROPERTY HAVING ST. CLAIR COUNTY PARCEL NO. 06330302009 LOCATED AT 2635 OLD STATE ROUTE 3

- WHEREAS, the City of Columbia ("City"), Monroe and St. Clair Counties, Illinois is a duly created, organized and validly existing municipality of the State of Illinois under the 1970 Illinois Constitution and the laws of the State of Illinois, including particularly the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and
- WHEREAS, Section 13.02.010 of the Columbia Municipal Code prohibits properties in unincorporated areas from receiving municipal water or sewer service without first annexing into the City or entering into an annexation agreement; and
- WHEREAS, SLD Enterprises has applied to receive City of Columbia water service to unincorporated property legally described and depicted in the Plat of Survey, Exhibit A of the Agreement attached hereto (St. Clair Co. PIN #06330302009) located at 2635 Old State Route 3; and
- WHEREAS, all statutory requirements set forth by 65 ILCS 5/11 pertaining to Annexation Agreements have been met; and
- **WHEREAS**, it is necessary and appropriate that the City enact this Ordinance to authorize and approve the Annexation Agreement attached hereto.

NOW THEREFORE BE IT ORDAINED, by the Mayor and City Council of the City of Columbia, as follows:

- Section 1. The recitals contained above in the preamble of this Resolution are hereby incorporated by reference, the same as if set forth in this Section of this Resolution verbatim, as findings of the City Council of the City of Columbia, Illinois.
- Section 2. The Mayor is hereby authorized and directed to execute the Annexation Agreement for and on behalf of the City and the City Clerk is hereby authorized and directed to attest the same and affix thereto the Corporate Seal of the City.
- Section 3. The City Clerk or his designee is authorized and directed to record in the office of the Recorder of Deeds in and for St. Clair County, Illinois, a copy of the fully executed Annexation Agreement with a certified true copy of this Ordinance.
- Section 4. This Ordinance shall take full force and effect immediately upon passage by the Corporate Authorities.
