AN ORDINANCE AMENDING THE CODE OF THE CITY OF CRYSTAL LAKE

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF CRYSTAL LAKE, McHENRY COUNTY, ILLINOIS, as follows:

<u>SECTION I</u>: That CHAPTER 329 LIQUOR LICENSES Section 329-6 Limitations on licenses shall be as follows:

1. Class 23 License shall be increased from 0 to 1.

<u>SECTION II</u>: That this Ordinance shall be in full force and effect from and after its passage and approval according to law.

SECTION III: That all Ordinances and parts of Ordinances in conflict herewith are hereby repealed.

AN ORDINANCE GRANTING A SIGN VARIATION FOR THE OTHER SIDE AT 135 BEARDSLEY STREET

WHEREAS, pursuant to the terms of a Petition (File #PLN-2024-71) before the City of Crystal Lake, the Petitioner has requested a sign variation to allow a wall mural totaling 645 square feet of signage for The Other Side at 135 Beardsley Street; and

WHEREAS, a hearing of the request was held before the City of Crystal Lake City Council on May 21, 2024 in the manner and in the form as prescribed by Ordinance and Statute; and

WHEREAS, as a result of said hearing, the City Council made a motion to approve the sign variation as requested; and

WHEREAS, it is in the best interests of the City of Crystal Lake that the sign variation be granted as requested,

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF CRYSTAL LAKE, McHENRY COUNTY, ILLINOIS, as follows:

<u>Section I:</u> That a sign variation be granted to allow a wall mural up to 645 square feet, with for The Other Side at 135 Beardsley Street (14-33-351-055), Crystal Lake, Illinois.

Section II: Said sign variation is approved with the following conditions:

- 1. Approved plans, as approved by the City Council:
 - A. Application (Besant, dated 04/12/2024, received 04/17/2024)
 - B. Sign Plans (Besant, undated, received 04/17/2024)
- 2. The mural painting shall be maintained in good condition.
- 3. The approval for the mural is limited to the current tenant. Any future tenant request for a mural must be approved through the sign variation process.

4. If this business closes or relocates the façade must be painted to match the existing elevations within 90 days.

<u>Section III:</u> That the City Clerk be and is hereby directed to amend all pertinent records of the City of Crystal Lake to show the issuance of the sign variation in accordance with the provisions of this Ordinance, as provided by law.

Section IV: That this Ordinance shall be in full force and effect from and after its passage, approval and publication as provide by law.

WHEREAS Phase One will consist of meter testing, an investment grade audit, vendor symposium, a 20 year cost analysis, and recommendation of the meter and advance meter infrastructure technology followed by Phase Two consisting of the actual meter replacements; and

WHEREAS, the CITY requires a consultant to conduct the necessary evaluations, analysis, recommendations, and project management for Phase One of this program; and

WHEREAS, proposals were publically solicited and reviewed, resulting in a determination that Veregy offered a proposal that is the most advantageous to the City.

NOW THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF CRYSTAL LAKE that the foregoing recitals are repeated and incorporated as though fully set forth herein; and

BE IT FURTHER RESOLVED that the City Manager is authorized to execute an agreement with Veregy for a Water Meter Replacement Program to complete Phase One of the evaluation for a contract at a not-to-exceed amount of \$69,046.31; and

BE IT FURTHER RESOLVED that the City Manager is authorized to approve warranted change orders for up to ten percent (10%) of the agreement value and to approve warranted time extensions.
