AN ORDINANCE AUTHORIZING THE PURCHASE OF THREE 2023 DODGE DURANGO PURSUIT VEHICLES FROM LANDMARK DODGE FOR A TOTAL SUM NOT TO EXCEED ONE HUNDRED TWENTY-SIX THOUSAND SEVEN HUNDRED SIXTY DOLLARS (\$126,760.00)

WHEREAS, the City of Crestwood (the "City") Police Department ("Police Department") has requested the authority to purchase three 2023 Dodge Durango Pursuit vehicles in order to maintain the expected level of service provided by the Police Department; and

WHEREAS, there are available funds in the Police Department General Fund to purchase the three Dodge Durango Pursuit vehicles; and

WHEREAS, the purchase of the 2023 Dodge Durango Pursuit vehicles would reduce the Police Department's 2024 Capital Improvement Fund request and would be considered the Police Department's vehicle purchase for 2024; and

WHEREAS, the City's Purchasing Policy authorizes the purchase of items through Cooperative Purchasing Programs of the State of Missouri (the "Program"), and also provides that new equipment is to be preferred to used equipment; and

WHEREAS, the purchase of three 2023 Dodge Durango Pursuit vehicles fall under the Missouri State Purchasing Contract with Landmark Dodge; and

WHEREAS, City staff has found the cost of the vehicles obtained pursuant to the Program to be reasonable; and

WHEREAS, the Board of Aldermen deems the purchase of these vehicles necessary and has budgeted funds for said purchase.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF CRESTWOOD, MISSOURI, AS FOLLOWS:

SECTION 1: The Board of Aldermen hereby approves the purchase of three 2023 Dodge Durango Pursuit vehicles from Landmark Dodge pursuant to a quote received through the Cooperative Purchasing Programs of the State of Missouri, which is attached hereto as Exhibit A and incorporated herein by reference, in the total sum not to exceed One Hundred Twenty-Six Thousand Seven Hundred Sixty Dollars (\$126,760.00).

SECTION 2: The Mayor, City Administrator and City Clerk are hereby authorized and directed to execute such documents and to take such other actions as may be reasonably necessary to approve this purchase and to carry out the intent of this Ordinance.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage by the Board of Aldermen and its approval by the Mayor.
