ORDINANCE NO. 5388

AN ORDINANCE AMENDING THE FEE SCHEDULE APPROVED BY
ORDINANCE NO. 5358 FOR CERTAIN EMERGENCY SERVICES
PROVIDED BY THE CRESTWOOD FIRE DEPARTMENT

WHEREAS, Section 2.1 of the Charter of the City of Crestwood (the “City”) provides that the City shall have all powers, the General Assembly of the State of Missouri has authority to confer upon any city, provided such powers are consistent with the Constitution of this State and are not limited or denied either by the Charter or by statute, and that the City shall, in addition to its home rule powers, have all powers conferred by law; and

WHEREAS, on April 25, 2023, the Board of Aldermen of the City of Crestwood passed Ordinance No. 5358, adopting a fee schedule for certain emergency services provided by the Crestwood Fire Department; and

WHEREAS, the Fire Chief has proposed certain amendments to the fee schedule; and

WHEREAS, the Fire Chief has reviewed the amount of staff time and resources necessary to perform emergency services, and has determined that the fee schedule, as amended, accurately reflects the time and resources committed to processing the requests; and

WHEREAS, the Board of Aldermen finds that it would be in the best interest of the City to amend the fee schedule approved by Ordinance No. 5358.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF CRESTWOOD, MISSOURI, AS FOLLOWS:

SECTION 1: The Board of Aldermen of the City of Crestwood hereby amends the “Emergency Services Fee Schedule” adopted by Ordinance No. 5358, to reflect the revisions set forth in Exhibit A, attached hereto and incorporated by reference, and directs that the amended Fee

Schedule shall be posted in the office of the Fire Department, shall be on file in the office of the City Clerk, and shall also be posted in a manner accessible to members of the public.


SECTION 2: This Ordinance shall be in full force and effect from and after its passage by the Board of Aldermen and its approval by the Mayor.

EMERGENCY SERVICES FEE SCHEDULE

In accordance with Ordinance No. 5387, passed by the Board of Aldermen on September 12, 2023, the proposed fee schedule is hereby adopted:

Advanced Life Support, Level 1 (ALS1)	\$800.00
Advanced Life Support, Level 2 (ALS2)	\$900.00
Advanced Life Support, Assist	\$100.00
Basic Life Support, Level 1 (BLS1)	\$700.00
Treatment, No Transport	\$100.00
Loaded miles to the hospital	\$10.00 per mile
DOA	\$100.00
