ORDINANCE NO. 5435

AN ORDINANCE APPROVING A MUNICIPAL AND COST APPORTIONMENT AGREEMENT WITH THE MISSOURI DEPARTMENT OF TRANSPORTATION AND AUTHORIZING FUNDING TO PAINT OR POWDER COAT SIGNALING EQUIPMENT AT SIX INTERSECTIONS ALONG WATSON ROAD WITHIN THE CITY OF CRESTWOOD, MISSOURI

WHEREAS, the Missouri Department of Transportation (“MoDOT”) is replacing or refurbishing signaling equipment at six intersections along Watson Road in the City of Crestwood, Missouri (the “City”) as part of MoDOT’s Watson Road Improvement Project; and

WHEREAS, City staff believes that painting or powder coating the refurbished or newly installed signaling equipment along Watson Road will improve traffic in the area and enhance public safety; and

WHEREAS, MoDOT provided City staff with an estimate of \$68,275 for the painting or powder coating of the signaling equipment; and

WHEREAS, MoDOT requires a Municipal and Cost Apportionment Agreement with the City to establish the City’s responsibility to maintain and upkeep the paint and powder coated signaling equipment and to fund the enhancement; and

WHEREAS, the Board of Aldermen hereby finds the cost for the paint and powder coating of the signaling equipment at six intersections along Watson Road to be reasonable, and that an Agreement ensuring proper maintenance and upkeep would be in the best interest of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF CRESTWOOD, MISSOURI, AS FOLLOWS:

SECTION 1: The Board of Aldermen hereby approves the transfer of Sixty-Eight Thousand Two Hundred Seventy-Five Dollars and Zero Cents to the Missouri Department of

Transportation for the painting or powder coating of certain refurbished or replaced signaling equipment at six intersections along Watson Road, including:

1. Sturdy Intersection;
2. Glenwood Intersection;
3. Sappington Intersection;
4. Watson Industrial/Brookview Intersection;
5. Pardee Intersection; and
6. Grant Intersection.

SECTION 2: An Agreement with the Missouri Department of Transportation to provide the funding and establish the maintenance and upkeep of the aforementioned painted and powder coated signaling equipment at six intersections along Watson Road is hereby approved in substantially the same form as attached hereto as Exhibit A, and is incorporated herein by reference.

SECTION 3: The Mayor, City Administrator, Director of Public Works, and City Clerk are hereby authorized and directed to execute any such documents and to take such other actions as may be reasonably necessary to approve the Agreement and to carry out the intent of this Ordinance.


SECTION 4: This Ordinance shall be in full force and effect from and after its passage by the Board of Aldermen and its approval by the Mayor.
