ORDINANCE NO. 5472

AN ORDINANCE AUTHORIZING THE PURCHASE OF ONE 2024 DODGE DURANGO PURSUIT VEHICLE FROM LANDMARK DODGE FOR A TOTAL SUM NOT TO EXCEED FORTY-THREE THOUSAND EIGHT HUNDRED EIGHTY TWO DOLLARS AND ZERO CENTS (\$43,882.00)

WHEREAS, the City of Crestwood (the “City”) Police Department (“Police Department”) has requested the authority to purchase one 2024 Dodge Durango Pursuit vehicle in order to maintain the expected level of service provided by the Police Department; and

WHEREAS, the City’s Purchasing Policy authorizes the purchase of items through Cooperative Purchasing Programs of the State of Missouri (the “Program”), and also provides that new equipment is to be preferred to used equipment; and

WHEREAS, the purchase of a 2024 Dodge Durango Pursuit vehicle falls under the Missouri State Purchasing Contract with Landmark Dodge; and

WHEREAS, City staff has found the cost of the vehicle obtained pursuant to the Program to be reasonable; and

WHEREAS, the Board of Aldermen deems the purchase of the vehicle necessary and has budgeted funds for said purchase.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF CRESTWOOD, MISSOURI, AS FOLLOWS:

SECTION 1: The Board of Aldermen hereby approves the purchase of one 2024 Dodge Durango Pursuit vehicle from Landmark Dodge pursuant to a quote received through the Cooperative Purchasing Programs of the State of Missouri, which is attached hereto as Exhibit A

and incorporated herein by reference, in the total sum not to exceed Forty-Three Thousand Eight Hundred and Eighty-Two Dollars and Zero Cents (\$43,882.00).

SECTION 2: The Mayor, City Administrator and City Clerk are hereby authorized and directed to execute such documents and to take such other actions as may be reasonably necessary to approve this purchase and to carry out the intent of this Ordinance.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage by the Board of Aldermen and its approval by the Mayor.
