ORDINANCE NO. <u>5441</u>

AN ORDINANCE AUTHORIZING THE PURCHASE OF FIREFIGHTER TURNOUT GEAR FROM MACQUEEN EMERGENCY FOR THE CITY OF CRESTWOOD, MISSOURI FIRE DEPARTMENT

WHEREAS, the City of Crestwood (the "City") Fire Department has requested the purchase of four sets of firefighter turnout gear; and

WHEREAS, the National Fire Protection Association has a mandatory retirement of turnout gear after ten years; and

WHEREAS, the City's Purchasing Policy authorizes the purchase of items through cooperative purchasing programs of the State of Missouri (the "Program"); and

WHEREAS, the Equipment Committee of the City Fire Department has re-evaluated the vendors for firefighting turnout gear and unanimously chose Globe Athletix Gear; and

WHEREAS, MacQueen Emergency is the local vendor for Globe Athletix Gear; and

WHEREAS, City staff has found the cost of the turnout gear pursuant to the Program to be reasonable; and

WHEREAS, the Board of Aldermen deemed this purchase necessary and budgeted funds for said purchase.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF CRESTWOOD, MISSOURI, AS FOLLOWS:

<u>SECTION 1</u>: The Board of Aldermen hereby approves the purchase of firefighter turnout gear from MacQueen Emergency pursuant to a quote, which is attached hereto as <u>Exhibit A</u> and

incorporated herein by reference, in the total sum not to exceed Twenty Eight Thousand Six Hundred Twenty One Dollars and One Cent (\$28,621.01).

<u>SECTION 2</u>: The Mayor and City Clerk are hereby authorized and directed to execute such documents and to take such other actions as may be reasonably necessary to approve this purchase and to carry out the intent of this Ordinance.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage by the Board of Aldermen and its approval by the Mayor.
