

ORDINANCE NO. 08-2024-01

AN ORDINANCE OF THE CITY OF CROSBYTON, TEXAS REPEALING AND REPLACING APPENDIX A, FEE SCHEDULE, ARTICLE A7.000 MUNICIPAL COURT FEES, SECTION A7.002, BUILDING SECURITY FUND FEE, OF THE CITY OF CROSBYTON CODE OF ORDINANCES, INCREASING THE BUILDING SECURITY FUND FEE TO BE CONSISTENT WITH STATE LAW; PROVIDING AN EFFECTIVE DATE; PROVIDING A SAVINGS CLAUSE AND PROVIDING A REPEALER.

WHEREAS, the City Council has previously established various fees in its Code of Ordinances as detailed in Appendix A, Fee Schedule; and

WHEREAS, in 2020, the building security fund fee was increased in state law; and

WHEREAS, the City Council finds the following amendment to be reasonable and beneficial and in the best interest of the public health, safety, and welfare of the residents of the City of Crosbyton, Texas;

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Crosbyton, Texas that the Code of Ordinances is amended to read as follows:

SECTION I

A. Code of Ordinances, City of Crosbyton, Texas, Appendix A, Fee Schedule, Article A7.000 Municipal Court Fees, Sec. A7.002, Building Security Fund Fee, the following line item is hereby deleted and replaced with the following:

A7.002. Building Security Fund Fee.
Building security fund fee: \$4.90.

SECTION II.

Repealer. All other terms and provisions of the Code of Ordinances of the City of Crosbyton, not in conflict herewith and not hereby amended, shall remain in full force and effect.

SECTION III.

Severability. If any provision, section, subsection, sentence, clause or the application of same to any person or set of circumstances for any reason is held to be unconstitutional, void or invalid or for any reason unenforceable, the validity of the remaining portions of this ordinance or the application thereby shall remain in effect, it being the intent of the City Council of the City of Crosbyton, Texas in adopting this ordinance, that no portion thereof or provision contained herein shall become inoperative or fail by any reasons of unconstitutionality of any other portion or provision.

SECTION IV.

Effective Date. This Ordinance shall take effect immediately upon its adoption by the City Council and publication as may be required by governing law.

SECTION V.

Open Meetings. It is hereby officially found and determined that the meeting at which this Ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551, Gov't. Code.
