A RESOLUTION

A RESOLUTION IN ACCORDANCE WITH THE PROVISIONS OF SECTION 901 OF THE PENNSYLVANIA BOROUGH CODE APPOINTING HEATHER D. BURKE OF 202 HESS STREET, BOROUGH OF DALTON, COUNTY OF LACKAWANNA, COMMONWEALTH OF PENNSYLVANIA TO FILL THE VACANCY IN THE OFFICE OF MEMBER OF COUNCIL FOR THE BOROUGH OF DALTON.

WHEREAS, Brendan Dwyer, a duly elected Member of Council of the Borough of Dalton recently submitted his resignation and Dalton Borough Council by Motion regretfully accepted his resignation; and,

WHEREAS, Dalton Borough Council Nominating Committee has recommended Dalton Resident Heather D. Burke, to fill the vacancy on Dalton Borough Council; and,

WHEREAS, Heather D. Burke has indicated a willingness to serve as a Member of Dalton Borough Council.

NOW THEREFORE, be it *RESOLVED* by the Council of the Borough of Dalton, Lackawanna County, Commonwealth of Pennsylvania, that Heather D. Burke, registered elector residing at 202 Hess Street, Borough of Dalton, County of Lackawanna, Commonwealth of Pennsylvania, is appointed Member of Council of the Borough of Dalton, to hold office in accordance with the provisions of the Borough Code Section 901.

SECTION 1. This Resolution is effective immediately upon passage.


