AN ORDINANCE AMENDING CHAPTER 3 – ARTICLE 7 OF THE DEPTFORD TOWNSHIP CODE (FIRE LANES) TO DESIGNATE FIRE LANES IN THE NARRATICON ASSOCIATION

WHEREAS, the Narraticon Association has requested fire lanes on Laurel Court, Bayberry Court, and Arrowwood Court due to safety concerns; and

WHEREAS, the Deptford Township Fire Marshall has reviewed these parking problems and believes that fire lanes need to be established to allow for fire department access,

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Deptford as follows:

- Section 1. Chapter 3 Article 7 of the Township Code (Fire Lanes) is hereby amended to designate the following areas in the Narraticon Association as fire lanes:
 - a. In front of #1 Laurel Court
 - b. In front of #5 Laurel Court
 - c. In front of #19, 20, and 21 Bayberry Court
 - d. In front of #37 Arrowwood Court
- Section 2. The definitions listed in 3-7.6 are continued as they apply to the Narraticon Association.
- Section 3. The provisions of 3-7.7 (Enforcement), 3-7.8 (Parking in Fire Lane Prohibited) and 3-7.9 (Violations and Penalities) shall apply to the fire lanes in the Narraticon Association.
- Section 4. The provisions in 3-7.10 (Towing of Vehicles in Violation) shall continue as they apply to the Narraticon Association.
- Section 5. Any provision of any Ordinance inconsistent with the provisions of this Ordinance are hereby repealed.
- Section 6. If any sections or provisions of this Ordinance shall be ruled invalid such rule shall apply only to the section or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

Section 7. This Ordinance shall take effect twenty (20) days after adoption and publication pursuant to law.
