WHEREAS, in an effort to ensure the Township is properly reimbursed for the costs associated with the processing of, and issuance of, licenses for vendors Township Council feels it is appropriate to re-examine and adjust these fees; and

WHEREAS, the Township last re-examined and revised the license fees and registration fees for peddlers, hawkers, vendors, and seasonal sales vendors in 1991 via Ordinance O.4.91; and

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and Township Council of the Township of Deptford, in the County of Gloucester, State of New Jersey, as follows:

Section 1. Deptford Township Municipal Code §4-2.8 shall be amended to read as follows:

a. License fee. The Department of Community Development fee for the issuance of a license hereunder shall be as stated below. This license fee includes all costs associated with processing the application and investigation of the facts stated herein for a license, as well as each individual to be registered and employed by the organization and/or business.

1. Peddlers, hawkers, vendors, solicitors and canvassers license: \$595.00

2. Seasonal sales vendor license: \$325.00

b. No registration or license fee shall be required from any charitable or religious nonprofit organization which services the Township and which are exempt from the payment of taxes under the regulations of the Internal Revenue Service.

c. Any nonprofit organization must demonstrate that it has been a nonprofit organization for a period of at least two continuous years as a condition of being exempt from payment of registration and licensing fees.

Section 2. Repealer. All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflict.

Section 3. Severability. If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not effect the remaining provisions of this ordinance. The governing body of the Township of Deptford declares that it would have passed the ordinance and each section and subsection thereof,

irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

Section 4. Effective Date. The ordinance shall take effect immediately upon passage and publication according to law.
