ORDINANCE OF THE TOWNSHIP OF DEPTFORD AMENDING TOWNSHIP CODE CHAPTER 9 ENTITLED "PARKS AND RECREATION AREAS"

WHEREAS, the Township Council of the Township of Deptford in the County of Gloucester, State of New Jersey desires that Chapter 9, Section 1.2 of the Code of the Township of Deptford be amended.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Township Council of the Township of Deptford, in the County of Gloucester, State of New Jersey as follows:

Section 1. Deptford Township Code §9-1.2(a)(3) is hereby amended to read:

Obtain the written permission of the Township Manager before bringing any buses or charter groups over 20 people into park premises, in accordance with Deptford Township Code 9-1.2(b)(4).

Section 2. Deptford Township Code §9-1.2(b)(4) is hereby added and shall read as follows:

 $\frac{9-1.2(b)(4)}{-}$ Parking of buses, trucks and cargo vans.

(a) Buses, trucks, cargo vans, shuttle buses with seats for more than 15 people may not park at any Deptford Township-owned or controlled park, playground or playing field without having obtained a permit from the Township Manager unless such bus is related to a scheduled game with a team or organization having a lease or permit from the Township of Deptford. Applications must be completed and submitted with the proper fee of \$125. Applications for a bus permit must be submitted at least 10 days in advance to allow the Township time to process the application. If an application form is not received within 10 days prior to arrival, there will be a late fee of \$10. Only persons who have secured advance bus permits may park, load or unload buses within the Deptford Township-owned controlled park, playground or playing field parking lot or adjacent areas. Permits shall be limited so that no more than two buses are scheduled to park at the controlled park, playground or playing field parking lot on any given day. Permits must be displayed in the windshield of the bus while the bus is within the Deptford Townshipcontrolled park, playground or playing field parking lot.

(b) Persons who park, load or unload buses within the Deptford Township-owned controlled park, playground or playing field parking lot or adjacent areas without first obtaining a permit shall, upon conviction be subject to the General Penalty established in Section 1-5 of this Code.

Section 3. Repealer. All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflict.

Section 4. Severability. If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the remaining provisions of this ordinance. The governing body of the Township of Deptford declares that it would have passed the ordinance and each section and subsection thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

Section 5. Effective Date. The ordinance shall take effect immediately upon passage and publication according to law.
