Grant

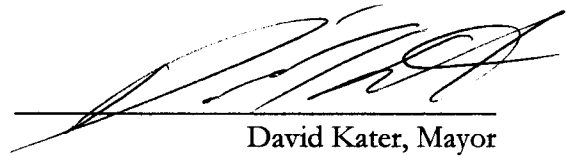
Administrator Bryan gave the board a heads up on a grant he was trying to get. He needs a resolution from the board approving the participation for the next meeting.

Adjourn

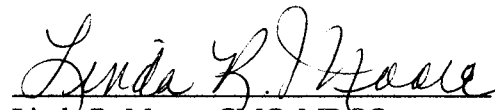
