## ORDINANCE NO. 19-23

## AN ORDINANCE OF THE TOWNSHIP OF DENVILLE, COUNTY OF MORRIS, STATE OF NEW JERSEY, TO AMEND CHAPTER 550, VEHICLES AND TRAFFIC, TO PROHIBIT PARKING WITHIN THE REGENCY AT DENVILLE DEVELOPMENT

**WHEREAS**, the Homeowners Association of the Regency at Denville has requested that the Township of Denville implement parking restrictions on certain roads in the development; and

WHEREAS, the Mayor and Administration, with the concurrence of the Police Chief, have recommended prohibiting or limiting parking on certain streets; and

**WHEREAS**, the Municipal Council finds it in the best interest of the health, safety and welfare of the Township to amend the Code to implement and modify these parking restrictions.

**NOW, THEREFORE, BE IT ORDAINED**, by the Municipal Council of the Township of Denville, County of Morris, State of New Jersey, as follows:

**SECTION 1.** Chapter 550, Vehicles and Traffic, Article II, Parking, § 550-5, Parking prohibited at all times on certain streets, § 550-40, Schedule 1: No Parking, of the Township Code is hereby amended as follows:

**SECTION 2.** Chapter 550, Vehicles and Traffic, Article II, Parking § 550-6, Parking prohibited during certain hours on certain streets, § 550-42, Schedule 11: Parking Prohibited Certain Hours, subsection B, School days, of the Township Code is hereby amended as follows :

McKenzie Lane South	West	9:00 a.m. to 2:00 p.m.	From the intersection with Hogan Drive to the intersection with Astro Place.
McKenzie Lane South	Both	9:00 a.m. to 2:00 p.m.	From the intersection with Astro Place to end/entrance to Hollstein Lake Park
McKenzie Lane North	Both	9:00 a.m. to 2:00 p.m.	Entire length

**SECTION 3.** All ordinances of the Township of Denville that are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 4.** If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

**SECTION 5.** This Ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law, and upon posting of appropriate signage.
