ORDINANCE NO. 08-24

AN ORDINANCE PROVIDING FOR VARIOUS IMPROVEMENTS OR PURPOSES IN THE SUM OF \$1,421,500 FROM THE GENERAL CAPITAL IMPROVEMENT FUND OF THE TOWNSHIP OF DENVILLE, IN THE COUNTY OF MORRIS, NEW JERSEY

BE IT ORDAINED, by the Municipal Council of the Township of Denville, in the County of Morris and State of New Jersey (the "Township") as follows:

SECTION 1. The sum of \$1,421,500 is hereby appropriated from the General Capital Improvement Fund of the Township for the purposes set forth in Section 2 of this ordinance.

SECTION 2. The improvements authorized to be paid by this ordinance include pagers (\$5,000); Scott bottles (\$5,500); portable radios (\$5,000); Scott packs (\$38,000); firefighter gear (\$60,000); hose replacement (\$25,000); gas meters (\$20,000); fire utility truck (\$65,000); Fire Department engine (\$475,000); Police Department server upgrade (\$10,000); Detective Bureau vehicle (\$58,000); Police building addition (\$30,000); sign and line materials (\$19,000); DPW used truck bodies (\$120,000); DPW equipment (\$91,000); DPW truck (\$65,000); repairs for Building and Grounds (\$32,000); roof replacement and repairs (\$50,000); video security upgrades (\$48,000); Municipal server upgrade (\$20,000); crack sealing supplies (\$50,000); miscellaneous drainage improvements (\$10,000); fire alarm system upgrade (\$50,000); Municipal vehicles (\$70,000); and for items located in and for the Township and all work necessary in connection therewith.

SECTION 3. No debt is to be authorized by the enactment and passage of this Ordinance.

SECTION 4. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

SECTION 5. All ordinances of the Township which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 6. If any section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this ordinance.

SECTION 7. This ordinance shall take effect immediately upon final passage, approval and publication as required by law.
