ORDINANCE NO. 15-24

AN ORDINANCE OF THE TOWNSHIP OF DENVILLE, COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING CHAPTER 245, FEES, RATES AND CHARGES, OF THE TOWNSHIP CODE TO ESTABLISH A SPECIAL LICENSE FOR YOUTH SCOUTING PROGRAMS SELLING PREPACKAGED, COMMERCIALLY PREPARED FOOD

WHEREAS, Chapter 277 of the Township of Denville Code regulates the licensing of retail food establishments, which as defined, includes nonprofit organizations selling food products; and

WHEREAS, section 245-6C of the Township of Denville Code establishes license fees for retail food establishments; and

WHEREAS, the Township desires to establish a special license for youth scouting programs selling prepackaged, commercially prepared food, at no cost to Denville-based troops and at an annual fee of \$75 for non-Denville-based troops; and

WHEREAS, the Township Council now desires to amend the Township Code to make the make this amendment.

NOW, THEREFORE, BE IT ORDAINED, by the Municipal Council of the Township of Denville, County of Morris, State of New Jersey, as follows:

SECTION 1. Part II: General Legislation, Chapter 245, Fees, Rates and Charges, § 245-6, Health, paragraph C, Licensing retail and mobile food establishments before February 1, is hereby amended to read as follows:

- (1) Risk Type 1: \$100.
- (2) Risk Type 2: \$200.
- (3) Risk Type 3: \$300.
- (4) Risk Type 4: \$300.
- (5) Risk Type 3 and 4: \$400.
- (6) Surcharge for establishments over 10,000 square feet: \$150.
- (7) Late fee for applications received after January 31: \$100.
- (8) Mobile food establishment: \$150.
- (9) Vending machine (non-potentially hazardous food): \$20.
- (10) Vending machine (potentially hazardous food): \$50.
- (11) Annual license for youth scouting programs (e.g. Scouting America, Girl Scouts of the USA) to sell prepackaged, commercially prepared food only. No fee for Denville-based troops; \$75 fee for non-Denville-based troops.
- (12) Temporary food establishment less than one week:
 - (a) Blanket temporary food establishment license: \$20.
 - (b) Individual booth, stand or other conveyance: \$20.
 - (c) Farmer's market blanket license: \$50. [Chapter 600, Land Use.]
 - (d) Farmer's market individual vendor: \$50. [Chapter 600, Land Use.]
- (13) Re-inspection fee for first and subsequent conditional/unsatisfactory rating: \$250.
- (14) Grease trap registration fee: \$50. [Chapter 437, Article VIII, Grease Interceptors.]

<u>SECTION 2.</u> Ordinances, resolutions, regulations or parts of ordinances, resolutions and regulations inconsistent herewith are hereby repealed to the extent of such inconsistencies.

SECTION 3. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by a court of competent jurisdiction, such a decision shall not affect the remaining portions of this Ordinance.

SECTION 4. This Ordinance shall take effect twenty (20) days following final passage, approval, and publication as required by law, and upon erection of appropriate signage reflecting the new time limits.
