The City of Dover Ordains:

# 1. **PURPOSE**

This ordinance is intended to update the Dover Code consistent with a companion ordinance concerning Chapter 109 clarifying licensing in light of recent legislation repealing RSA chapter 320.

# 2. AMENDMENT

Chapter 97 entitled "Licensing" is hereby amended by revising Section 97-3, "Fees", as follows:

# a. THE FOLLOWING ARE AMENDED:

# § 97-3 Fees.

Every licensee shall pay in advance for such license, for the use of the City, such sum or sums as the City Council may determine, but in no case shall such license fee be in excess of the maximum sum fixed in RSA 286, except where the City Council or Licensing Board determines per RSA 286:4-a that the fee is inadequate to reimburse the City for the extra expense in protecting the health and safety of the public which can reasonably be attributed to the event to be licensed.

## 3. AMENDMENT

Chapter 97 entitled "Licensing" is hereby amended by revising Section 97-6, "Street Fairs, Soliciting Funds, Raffles, Peddlers and Vendors", as follows:

## a. THE FOLLOWING ARE AMENDED:

# § 97-6 Street Fairs, Soliciting Funds, Raffles, Peddlers and Vendors.

The Licensing Board shall have authority in the first instance to consider and, if appropriate, issue licenses or permits pursuant to RSA 31:100 (entitled "Street Fairs"), RSA 31:91 (entitled "Soliciting Funds"), RSA chapter 287-A (entitled "Raffles"), <u>RSA 31:102-a (entitled "Hawkers,</u> <u>Peddlers and Vendors")</u>, and/or Chapter **109**, Peddlers and Vendors, of the Code of the City of Dover, as applicable.

# 4. TAKES EFFECT

This ordinance shall take effect upon passage. The City Clerk shall cause publication of notice as required by RSA 47:18.
