#### ORDINANCE NO. 2023-11

AN ORDINANCE OF THE BOROUGH OF DOYLESTOWN, BUCKS COUNTY, PENNSYLVANIA AMENDING CHAPTER 15. SECTION 312 REMOVING A HANDICAPPED PARKING SPOT ON WEST ASHLAND STREET AT SOUTH HAMILTON STREET, CREATING A HANDICAPPED PARKING SPOT ON WEST OAKLAND AVENUE AT FRANKLIN STREET, AND CREATING A HANDICAPPED PARKING SPOT ON FRANKLIN STREET AT WEST OAKLAND AVENUE.

WHEREAS, the Pennsylvania Borough Code provides that the corporate powers of the Borough Council (the "Borough Council") of the Borough of Doylestown ("Borough") include the ability to make regulations as may be necessary for the health, safety, and general welfare of the residents of the Borough;

WHEREAS, Chapter 15 of the Borough of Doylestown Code of Ordinances ("Borough Code") regulates motor vehicles and traffic, including parking;

WHEREAS, Section 312 of Chapter 15 of the Borough Code provides for special purpose parking zones with parking otherwise prohibited;

**WHEREAS,** the Borough desires to remove a handicapped parking spot on the north side of West Ashland Street south of the intersection with South Hamilton Street;

**WHEREAS,** the Borough desires to add a handicapped parking spot on the north side of West Oakland Avenue west of the intersection with Franklin Street;

**WHEREAS,** the Borough desires to add a handicapped parking spot on the west side of Franklin Street north of the intersection with West Oakland Avenue;

WHEREAS, the Borough determined that these changes promote the health, safety, and general welfare of Borough residents;

WHEREAS, the proposed amendment has been advertised, considered, and reviewed in accordance with the Borough Code;

**NOW THEREFORE,** in consideration of the foregoing, be it **ENACTED** and **ORDAINED** by the Borough Council of the Borough of Doylestown, Bucks County, Pennsylvania, as follows:

I. Chapter 15, Section 312, of the Borough Code entitled "Special Purpose Parking Zones Established; Parking Otherwise Prohibited" is hereby AMENDED by REMOVING the following from the table in Section 312:

# II. Chapter 15, Section 312, of the Borough Code entitled "Special Purpose Parking Zones Established; Parking Otherwise Prohibited" is hereby AMENDED by ADDING the following to the table in Section 312:

## III. Chapter 15, Section 312, of the Borough Code entitled "Special Purpose Parking Zones Established; Parking Otherwise Prohibited" is hereby AMENDED by ADDING the following to the table in Section 312:

## **IV.** Partial Repealer

All other provisions of the Borough Code, as amended, shall remain in full force and effect. All other Ordinances or provisions of the Borough Code inconsistent herewith or in conflict with any of the terms hereof are, to the extent of said inconsistencies or conflicts, are hereby specifically repealed.

#### V. Severability

The provisions of this Ordinance are severable. If any section, clause, sentence, part or provision thereof shall be held illegal, invalid, or unconstitutional by a court of competent jurisdiction, such decision of the court shall not affect or impair any of the remaining sections, clauses, sentences, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Borough Council that this Ordinance would have been adopted if such illegal, invalid, or unconstitutional section, clause, sentence or part of a provision had not been included herein.

## VI. Effective Date

All provisions of this Ordinance shall be in full force and effect five (5) days after the approval and adoption.
