BOROUGH OF DRAVOSBURG ORDINANCE NO. 2024-01

AN ORDINANCE OF THE BOROUGH OF DRAVOSBURG, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, LEVYING TAXES UPON REAL PROPERTY LOCATED IN THE BOROUGH OF DRAVOSBURG AND FIXING THE MILLAGE RATE AT 7.55 FOR GENERAL BOROUGH PURPOSES AND 1.0 MILL FOR THE PURPOSE OF MAKING APPROPRIATIONS TO DRAVOSBURG VOLUNTEER FIRE DEPARTMENT NO. 1, A FIRE COMPANY WITHIN THE BOROUGH

WHEREAS, Section 1302 (a) of the Borough Code, Pa. Cons. Stat. Ann. tit. 8, §1302 (a), authorizes a borough council to levy and collect annually a tax on real property not to exceed thirty (30) mills for general borough purposes.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE COUNCIL OF THE BOROUGH OF DRAVOSBURG, IN LAWFUL SESSION DULY ASSEMBLED, AS FOLLOWS:

SECTION 1. LEVY OF TAXES ON REAL PROPERTY FOR 2024; MILLAGE RATE

A. The Borough Council of the Borough of Dravosburg hereby levies a tax on all real property and other objects of taxation within the Borough of Dravosburg subject to taxation for the 2024 Fiscal Year as follows: Tax Rate for General Purposes at the sum of 7.55 Mills on each dollar of assessed valuation, or the sum of 0.755 cents per One Hundred Dollars (\$100.00) of assessed valuation of real property subject to taxation within the Borough.

SECTION 2. DRAVOSBURG VOLUNTEER FIRE DEPARTMENT FOR 2024; MILLAGE RATE

- A. The Borough Council of the Borough of Dravosburg hereby levies a tax on all real property and other objects of taxation within the Borough of Dravosburg subject to taxation for the 2024 Fiscal Year as follows: Tax Rate for the Dravosburg Volunteer Fire Department No. 1 ("Department") at the sum of 1.00 Mills on each dollar of assessed valuation, or the sum of 0.1 cents per One Hundred Dollars (\$100.00) of assessed valuation of real property subject to taxation within the Borough.
- B. This tax provides sufficient revenue to make appropriations and/provide financial support for the Department during the 2024 Fiscal Year. However, the revenues of the tax can only be used for paying existing Debt Service on any rescue or other fire vehicle currently owned by the Department.
- C. Additionally, to the extent that revenues generated by the tax are in excess of any existing current debt service on any rescue or other fire vehicle owned by the Department, such excess revenues generated by the tax shall only be used to pre-pay any existing but not currently due debt service on any rescue or other fire vehicle

owned by the Department until such existing debt service is completely paid off and satisfied.

D. Further, the payment or pre-payment of existing debt service on any rescue or other fire vehicle owned by the Department shall be handled and paid directly by the Borough of Dravosburg to the debt service holder such that no revenues generated by the tax shall be directly paid over and transferred to the Department.

SECTION 3. REPEALER

Any previous Ordinances or Resolutions, or any part thereof, which conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.
