#### LOCAL LAW 06 OF THE YEAR 2024

# AMENDMENT OF THE VILLAGE OF DRYDEN ZONING LAW AND ZONING MAP TO EXTEND THE CURRENTLY EXISTING RESIDENTIAL B DISTRICT SO AS TO INCLUDE A PORTION OF THE CURRENTLY EXISTING RESIDENTIAL A DISTRICT

Be it enacted by the Board of Trustees of the Village of Dryden as follows:

#### SECTION I. PURPOSE AND INTENT.

The purpose and intent of this Local Law is to amend the Village of Dryden Zoning Law and Zoning Map so as to provide for the expansion of the Residential B District south of East Main Street and adjacent to Wellsley Drive by adding an area (consisting of two parcels) situated within the currently existing and adjoining Village of Dryden Residential A district, with the boundary lines between such Districts to be modified accordingly; it having been determined that (i) the additional area to be added to the Residential B District is appropriate and beneficial to better serve the purposes of the Residential B Districts and to provide for more opportunity for housing development within the Village of Dryden, and (ii) the addition of such area to the Residential B District will not have any adverse effects on either the Residential A zone from which such area will be removed or the overall Zoning Districts of the Village.

#### SECTION II. AMENDMENTS.

The Village of Dryden Zoning Law and Zoning Map are hereby amended so as to provide for the easterly extension and expansion of that portion of the currently existing Residential B District south of East Main Street and adjacent to Wellsley Drive such that Tax Parcels Nos. 16.-2-5.1 and 16.-2-5.2 currently included in the Village of Dryden Residential A District, shall now be part of the Village of Dryden Residential B District, with the boundary lines between such Districts to be modified accordingly.

#### SECTION III. SUPERSEDING EFFECT.

All ordinances, local laws, resolutions, rules, regulations and other enactments of the Village of Dryden in conflict with the provisions of this Local Law are hereby superseded to the extent necessary to give this Local Law full force and effect.

#### SECTION IV. VALIDITY.

The invalidity of any provision of this Local Law shall not affect the validity of any other provision of this Local Law that can be given effect without such invalid provision.

#### SECTION V. EFFECTIVE DATE.

This Local Law shall be effective ten (10) days after publication and posting as required by law, except that it shall be effective from the date of service as against a person served with a copy thereof, certified by the Village Clerk, and showing the date of its passage and entry in the Minutes of the Village Board of Trustees.
