Village of Dundee

Local Law 1 of the year 2026

A Local Law authorizing a real property tax levy in excess of the limit established pursuant to General Municipal Law Section 3-c by the State of New York for the 2026-2027 Village fiscal year.

Be it enacted by the Village of Dundee as follows:

Section 1. Short Title.

This Local Law shall hereafter be known as the “Village of Dundee Tax Cap Override Law of 2026.”

Section 2. Legislative Intent

The intent of this Local Law is to allow the Village of Dundee to adopt a budget for the fiscal year commencing June 1, 2026 that requires a real property tax levy in excess of the “tax levy limit” as defined by General Municipal Law §3-c and set by the State of New York.

Section 3. Legislative Authority.

This Local Law is enacted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government’s governing body to override the property tax cap for the coming fiscal year by the adoption of a Local Law approved by a vote of sixty (60%) percent of said governing body.

Section 4. Provision.

§122-50 “Tax Cap Override” of Article V of Chapter 122, “Taxation”, of the Code of the Village of Dundee Is Amended To Provide As Follows:

§122-50. Tax Cap Override.

The Board of Trustees of the Village of Dundee, County of Yates, is hereby authorized to adopt a budget for the fiscal year commencing June 1, 2026 that requires a real property tax levy

in excess of the amount otherwise prescribed in General Municipal Law §3-c and set by the State of New York.

Section 5. Severability.

In the event that a court determines that any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair or invalidate the remainder of this Local Law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision or part of this Local Law or in its application to the person individual, firm or corporation or circumstance directly involved in the controversy in which such judgment or order shall be rendered.

Section 6. Effective date.

This Local Law shall take effect immediately upon its filing with the Secretary of State of the State of New York, subsequent to having been duly adopted by the Board of Trustees of the Village of Dundee.
