

ORDINANCE NO. 400

AN ORDINANCE OF THE BOROUGH OF DUNCANNON, PERRY COUNTY,
PENNSYLVANIA, AMENDING THE CODE OF THE BOROUGH OF
DUNCANNON, CHAPTER 155 PEDDLING AND SOLICITING

Section 1. Purpose

The purpose of this Ordinance is to provide that certain persons participating in festivals, parades and other public events, as more fully described in this Ordinance, are not subject to the license and license fee requirements of Chapter 155.

Section 2. Authority

This Ordinance is enacted under authority of the Borough Code, 53 P.S. §§ 46202(20) and 46203.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Council of Duncannon Borough:

Section 3. Amendment to Chapter 155 Peddling and Soliciting

Chapter 155 Peddling and Soliciting of the Code of the Borough of Duncannon, Section 155-2 License required; fees; exemptions shall be amended by adding the following subsection:

- G. No license or license fee shall be required or charged under this Section to any person selling, soliciting or taking orders for any goods, wares or merchandise as part of a festival, parade or other public event that has been authorized by the Borough Council to be conducted on the public streets and/or on public property in the Borough of Duncannon, so long as, no later than five business days prior to the

festival, parade or other public event: (i) the principal sponsor or organizer of the festival, parade or other public event confirms, in writing, that it has approved or by other means authorized or accepted the person as a participant in the festival, parade or other public event and (ii) the person registers with the Borough.

Section 4. Repealer

All ordinances, resolutions, rules and regulations of the Borough of Duncannon that conflict with this Ordinance are hereby repealed. All other ordinances, resolutions, rules and regulations of the Borough of Duncannon not repealed hereby shall remain in full force and effect.

Section 5. Effective Date.

This Ordinance shall take effect immediately.
