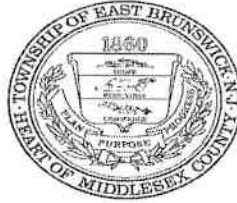


TOWNSHIP OF EAST BRUNSWICK

ORDINANCE NO: 24-07



ADOPTED: MAY 13, 2024

AN ORDINANCE OF THE TOWNSHIP OF EAST BRUNSWICK, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY, AMENDING CHAPTER 209, SECTION 62, ENTITLED "SCHEDULE XXIII: SPEED LIMITS," OF THE CODE OF THE TOWNSHIP OF EAST BRUNSWICK TO AMEND THE SPEED LIMIT ON NEW BRUNSWICK AVENUE

WHEREAS, the Township Council finds that it is in the best interest of the Township to amend the speed limit on New Brunswick Avenue to ensure the safety of the public; and

WHEREAS, due to traffic accident history, traffic volume, and the pending installation of bike lanes, it is recommended that the speed limit along New Brunswick Avenue from point 1285' north of Langley Road to Old Stage Road be reduced from 40 MPH to 35 MPH, which will result in a consistent speed limit of 35 MPH along the length of New Brunswick Avenue from Rues Lane to Old Stage Road.

BE IT ORDAINED, by the Township Council of the Township of East Brunswick in the State of New Jersey as follows:

SECTION 1. Chapter 209 of the Code of the Township of East Brunswick, Section §209-62, thereof, entitled "Schedule XXIII: Speed Limits," is hereby amended as follows:

§ 209-62 Schedule XXIII: Speed Limits

Pursuant to the provisions of § 209-65, speed limits are hereby established upon the following described streets or parts thereof:

Additions in italics

Table with 3 columns: Name of Street, Speed Limit (miles per hour), Location. It lists speed limit changes for New Brunswick Avenue in two zones and the entire length.

BE IT FURTHER ORDAINED, that if any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision

shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect, and to this end the provisions of this ordinance are hereby declared severable.

BE IT FURTHER ORDAINED, that all other ordinances in conflict or inconsistent with this ordinance are hereby repealed, to the extent of such conflict or inconsistency. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Township, the provisions hereof shall be determined to govern. All other parts, portions and provisions of the Ordinances of the Township are hereby ratified and confirmed, except where inconsistent with the terms hereof.

This Ordinance shall take effect twenty (20) days after final passage, adoption and publication according to law.


