LANCASTER COUNTY, PENNSYLVANIA**

ORDINANCE NO. 326

AN ORDINANCE OF THE BOROUGH OF EAST PETERSBURG, LANCASTER COUNTY, PENNSYLVANIA, AMENDING CHAPTER 116, ARTICLE III OF THE CODE OF THE BOROUGH OF EAST PETERSBURG TO PROHIBIT PARKING ON CERTAIN PORTIONS OF CARPENTER STREET NEAR THE INTERSECTION WITH RIDGE AVENUE.

WHEREAS, East Petersburg Borough has adopted Parking Regulations applicable to particular locations within the Borough; and

WHEREAS, an engineering study was conducted to assess the site distance and vehicular speeds in the area of the intersection of North Carpenter Street and Ridge Avenue within East Petersburg Borough; and

WHEREAS, a field investigation and speed study were completed by ARRO Consulting, Inc. and found the speed limit of 25 mph on Carpenter Street and Ridge Avenue was appropriate, but that the sight distance at the intersection was negatively impacted by vehicles parking along North Carpenter Street within the intersection sight triangles; and

WHEREAS, the engineering study recommended that additional areas of North Carpenter Street be designated as "no parking" areas to allow for sufficient sight distances in the area of the intersection of North Carpenter Street and Ridge Avenue and reduce the need for vehicles to utilize the center of the road while driving through the intersection. A copy of the study is attached hereto as Exhibit "A".

WHEREAS, the Borough Council wishes to provide specific regulations related to parking, stopping, and standing in the area of the North Carpenter Street and Ridge Avenue intersection to improve the health, safety, and welfare of the traveling public.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, and it is hereby Ordained and Enacted by the Borough Council of East Petersburg Borough, Lancaster County, Pennsylvania as follows:

Section 1. Chapter 116. Vehicles and Traffic, Article III. Parking Regulations, § 116-21. Parking, stopping and standing., Paragraph B shall be amended to include the following locations:

From Ridge Avenue extending 120 feet north	No parking	
From Ridge Avenue extending 100 feet south	No parking	

Section 2. All other provisions of Chapter 116, Article III, § 116-21 not amended by this Ordinance shall remain in full force and effect. Any Ordinance and any amendments thereto, or in any part thereof unless otherwise specified, inconsistent with the provisions of this Ordinance are hereby expressly repealed. Should any section of this Ordinance be declared by the Court to be unconstitutional or invalid, such decision shall not affect the validity of the ordinance as a whole, or any part thereof, other than the part so declared to be unconstitutional or invalid.

Section 3. This Ordinance shall become effective upon enactment by the Borough Council of the Borough of East Petersburg, County of Lancaster, Commonwealth of Pennsylvania.
