Local Law No. 1 of the year 2024

A local law To Amend NYS Municipal Law 103, Section 1 Best Value Standard

Be it enacted by the Town Board of the Town of East Bloomfield, as follows:

Proposed amendment to procurement policy

Remove current ~34-7 and relace with:

~34-7 Best value standard.

A. Authorization. The Town Board of the Town of East Bloomfield hereby enacts the following section pursuant to State of New York General Municipal Law § 103, Subdivision 1, and of all other applicable laws.

B. Definition of "best value." The Town of East Bloomfield hereby authorizes the use of the best value standard as part of Town procurement policies.

(2) "Best value" is defined in New York State Finance Law § 163. When awarding contracts under the best value standard, the Town must consider the overall combination of quality, price, and other elements of the required commodity or service that in total are optimal relative to the needs of the Town. Use of the best value standard must rely, wherever possible, on objective and quantifiable analysis. The best value standard may identify as a quantitative factor whether offers are from small businesses or certified minority- or women-owned business enterprises as defined in New York Executive Law § 310. The best value standard may only be used for purchase contracts, which includes contracts for service work, but excludes any purchase contracts necessary for the completion of a public works contract pursuant to Article 8 of the Labor Law.
