It is the intent of this local law to enact a temporary moratorium on the further growth and development of large-scale solar energy systems in the Town of East Bloomfield while the Town considers and potentially adopts changes to Chapter 135 Article X section 135-83.3 of the Town Code to address new circumstances not currently addressed in the Code.

The moratorium will provide municipal officials with time to study the code and address issues presented by the continued growth and development of large- scale solar energy systems within the Town and the impact of such growth on agriculture. Officials will consider the adequacy of existing regulation and control of such uses.

Pursuant to this moratorium, section Chapter 135, Article X, section 135-83.3 of the Town of East Bloomfield Code is hereby amended to suspend all further applications for development of large scale solar energy systems, as defined in section 135-83.3, for a period of one year on the acceptance, processing or approval of applications, special use permits, variances, site plans, subdivisions, or planned developments related to the undertaking, establishment, placement, development, excavation, enlargement, construction or erection of Large Scale Solar Energy Systems while Town officials consider the relevant issues associated with additional solar energy systems within the Town of East Bloomfield to address potential changes to the existing code and to consider issues not currently addressed in the code.

This local law shall take effect immediately upon filing with the Secretary of State
