Be it enacted by the Town Board of the

#### Town of East Bloomfield as follows:

#### **Section 1: Legislative Intent**

It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of East Bloomfield pursuant to General Municipal §3-c, and to allow the Town of East Bloomfield to adopt a budget for the fiscal year 2025 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c.

#### **Section 2: Authority**

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the tax levy limit for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

#### **Section 3: Tax Levy Limit Override**

The Town Board of the Town of East Bloomfield, County of Ontario, is hereby authorized to adopt a budget for the fiscal year 2025 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.
