Local Law 1 of 2022

A Local Law Amending Village Code Section 340-36 General Commercial Zoning

Be it enacted by the Village of East Syracuse Board of Trustees, County of Onondaga as follows:

Section 1-Legislative Intent:

It is the intent of this Local Law to amend and expand portions of Section 340-36 of the Village Code regarding General Commercial Zoning

Section 2-Authority:

This Local Law is adopted pursuant to Municipal Home Rule Law.

Section 3-Amnedments:

1. Section 340-36 General Commercial Zoning Paragraph "D (5)" shall be amended to read: "Existing single-and two-family residences are permitted uses only on W Terrace Street, East and West First and East Second Streets and may be replaced provided all area requirements are met; however no new residences can be constructed or existing structures converted to residences."

Section 4-Severability:

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm, corporation or circumstance, shall be adjusted by any Court of competent jurisdiction or found to be invalid or unconstitutional, such order or judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5-Effective Date:

This Local Law shall take effect immediately upon filing with the Secretary of State.
