RESOLUTION DESIGNATING EMERGENCY SERVICE PROVIDERS FOR

East Whiteland Township

WHEREAS the Board of Supervisors of East Whiteland Township is responsible under the Second-Class Township Code for the public safety of the residents of East Whiteland Township; and

WHEREAS, the Board of Commissioners of the County of Chester has requested that East Whiteland Township provide a resolution outlining the methods and agencies chosen to fulfill the public safety needs of East Whiteland Township for the efficient administration of the integrated emergency communications system of the Chester County Department of Emergency Services.

NOW, THEREFORE, BE IT RESOLVED the East Whiteland Township Department of Fire and Emergency Services and the East Whiteland Township Volunteer Fire Association will provide fire protection.

FURTHER, BE IT RESOLVED the East Whiteland Township Department of Fire and Emergency Services, the East Whiteland Township Volunteer Fire Association will provide ambulance services; and,

FURTHER, BE IT RESOLVED the East Whiteland Township Police Department will provide full time police protection and,

FURTHER, BE IT RESOLVED the East Whiteland Township Department of Fire and Emergency Services and the East Whiteland Township Volunteer Fire will provide rescue service; and,

FURTHER, BE IT RESOLVED that East Whiteland Township chooses to use Automatic Vehicle Location services to provide Advanced Life Support Services; and,

FURTHER, BE IT RESOLVED that Gregory Lewis Jr. is designated as Chief Fire Marshal; and

FURTHER, BE IT RESOLVED that Loren Nafziger is designated as Emergency Management Coordinator; and

FURTHER, BE IT RESOLVED that the Board of Supervisors of East Whiteland Township have reviewed and revised, if necessary, and adopted East Whiteland Township Emergency Operations Plan; and has reviewed and adopted the National Incident Management System as a common operating practice.

AND FURTHER, BE IT RESOLVED, the contact person(s) between said organizations and the Chester County Department of Emergency Services shall be Chief of Fire and Emergency Services Gregory Lewis Jr. and Chief of Police Chris Yeager.

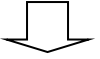

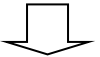

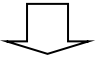
