TOWNSHIP OF EAST AMWELL ORDINANCE NO. 23-07

AN ORDINANCE AMENDING THE TOWNSHIP OF EAST AMWELL PERSONNEL POLICIES & PROCEDURES MANUAL, EMPLOYEE BENEFITS SECTION, BENEFITS SCHEDULE, SECTION FIVE, COMPENSATORY TIME

STATEMENT OF PURPOSE: The purpose of this Ordinance is to grant the DPW Superintendent a greater amount of compensatory time than that which is currently authorized.

WHEREAS, the Township of East Amwell presently has established in its Personnel Policies & Procedures Manual a policy of allowing up to 40 hours of compensatory time to be accrued by the Superintendent of Public Works; and

WHEREAS, the Mayor and Township Committee of the Township of East Amwell would like to recognize the valuable time and work performed by the Superintendent of Public Works, and desire to reward and recognize these valuable contributions to the Township by said Superintendent; and

WHEREAS, the Superintendent of Public Works has on occasion worked above and beyond the normal time spent performing his regular duties and there is a need to increase the current level of 40 hours of compensatory time to a greater amount of time.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF EAST AMWELL IN THE COUNTY OF HUNTERDON AND STATE OF NEW JERSEY, in accordance with N.J.S.A.40A:9-165, as follows:

SECTION FIVE: Compensatory Time

The DPW Superintendent is entitled to compensatory time that can be accrued per year. Any compensatory time above 40 hours shall be subject to approval by the Mayor or designated authorized Township Official. Any time accrued prior to June 30 of any given year must be used by the end of the year. Any time accrued after June 30 of any given year may be carried to the July 1 of the following year and must be utilized by then. Appropriate real-time tracking of the hours must be reported to the CFO.

This Ordinance shall become operative and take effect in 20 days after its publication after final passage per N.J.S.A. 40A:9-165.
