

**TOWNSHIP OF EAST AMWELL
ORDINANCE NO. 25-03**

AN ORDINANCE OF THE TOWNSHIP OF EAST AMWELL, COUNTY OF HUNTERDON, STATE OF NEW JERSEY, AMENDING CHAPTER 106, SECTION 3 (2) OF THE CODE OF THE TOWNSHIP OF EAST AMWELL, ENTITLED “PARKS AND RECREATION FACILITIES, USE OF FACILITIES” AND ARTICLE 1 ENTITLED “MISCELLANEOUS FEES”, CHAPTER 75, “FEES” SECTION 1 (A-1), “EVENT FEES AND MISCELLANEOUS FEES”

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of East Amwell, County of Hunterdon, State of New Jersey, that the Municipal Code of the Township of East Amwell is hereby amended as follows: (New language are underlined thus and deletions are indicated with strikethroughs ~~thus~~)

Section One. Chapter 106. “Parks and Recreation Facilities”, Section 106-3 “Use of facilities”

§ 106-3. Use of facilities.

Permit requirements for Marion F. Clawson Memorial Park:

(1) When there are more than 40 participants at one gathering or to reserve the pavilion, a permit is required. The applicant seeking issuance of the permit shall file an application, in writing, with the Municipal Clerk, stating the name and address of the applicant; name and address of the person, corporation or association sponsoring the activity, if any; the day and hours for which the permit is desired; the park or portion thereof for which the permit is desired; a reasonable estimate of the anticipated attendance; the type of activity for which the permit is desired; the anticipated age group of the expected participants; and any other information reasonably required of the applicant.

(2) A non-refundable application ~~application~~ pavilion rental fee of \$50 for 1-4 hours and an additional fee of \$25 per hour for pavilion rental in excess of four hours is required for all permits for use of the Marion F. Clawson Memorial Park. If you request a rain date, an additional non-refundable fee of \$15 is required.

Section Two. Chapter 75. Fees, Section 75-1 “Event fees and miscellaneous fees”

§ 75-1 Event fees and miscellaneous fees.

The following miscellaneous fees will be charged for the events listed:

A. The fees for recreational and athletic events shall be as follows:

(1) Non-refundable application pavilion rental fee for Marion F. Clawson Memorial Park. Permitted use: \$50 for 1-4 hours and an additional fee of \$25 per hour for pavilion rental in excess of four hours .

(2) Nonrefundable rain date fee: \$15.

Section Three. This Ordinance shall take effect upon its adoption, passage and publication according to law.
