ORDINANCE NO. 2024-01

AN ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF EAST CALN, AS AMENDED, AT CHAPTER 160, "SEWERS AND SEWAGE DISPOSAL," ARTICLE III. "WASTE DISCHARGE STANDARDS." SECTION 160-19. "PROHIBITIONS AND RESTRICTIONS ON INDUSTRIAL USERS," BY MODIFYING SUBSECTION B.(7) TO UPDATE LOCAL DISCHARGE LIMITS AS MANDATED BY THE DOWNINGTOWN AREA REGIONAL AUTHORITY, AND OTHER MISCELLANEOUS PROVISIONS CONTAINED HEREIN.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of East Caln Township, as follows:


<u>SECTION 1</u>. Chapter 160, "Sewers and Sewage Disposal," Section 160-19.B.(7) is hereby amended as follows, with underlining indicating additions, and strikethroughs indicating deletions, as follows:

(7) The following local discharge limits are established as follows:

Chromium	1.32
Copper <u>Cyanide, Free</u>	2.55<u>1.42</u> <u>0.57</u>

Zinc	2.18
Phenolics	0.12

<u>SECTION 2</u>. <u>Severability</u>. The provisions of this Ordinance are severable, and if any article, section, subsection, clause, sentence or part thereof shall be held or declared illegal, invalid or unconstitutional by any court of competent jurisdiction, the decision shall not affect or impair any of the remaining articles, sections, subsections, clauses,

sentences or parts thereof of this Ordinance. It is hereby declared to be the intent of the Board of Supervisors that this Ordinance would have been adopted if such illegal, invalid or unconstitutional article, section, subsection, clause, sentence or part thereof had not been included herein.

SECTION 3. Repealer. All Ordinances or part of Ordinances conflicting with any provision of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

SECTION 4. General Code. General Code is hereby authorized to make nonsubstantive formatting and numbering changes necessary to clarify references to other sections of the Valley Township ordinances and/or codification and to bring the Ordinance into conformity with the Valley Township ordinances/codification.

SECTION 5. Effective Date. This Ordinance shall be effective five days after adoption.
