AN ORDINANCE: AMENDING SECTION IN CHAPTER 285, PARKING GARAGE FEES, OF THE CODE OF THE CITY OF EASTON, PA

THE CITY OF EASTON HEREBY ORDAINS:

SECTION 1. Section 285-42 of the Code of the City of Easton, Pa., be and it is hereby amended to read as per attached Exhibit "A"

SECTION 2. All Ordinances or parts of ordinances inconsistent herewith be, and the same are hereby repealed.

SECTION 3. This ordinance shall take effect 30 days following adoption by Council.

(a) Twenty-four hour, for all garages: \$70.

(b) South Third Street Garage, government employees: \$50 from y:00 a.m. to 5:00 p.m. Monday through Friday.

B. Lost ticket: \$50, unless the user can prove that he or she entered on the ,same day, in which case the fee is \$24 for the Pine Street and North Fourth Street Garages and \$16 for the South Third Street Garage.

C. The Mayor and City Administrator is authorized to set fees for discounts and promotions.

D. The City will only deal directly with businesses currently licensed to do business in the City of Easton for discounts.

H. For customers who have contracted for between 40 and 59 spaces, the monthly fee for a twenty-four-hour pass shall be \$60 per pass. For customers with 60 passes or more, the monthly fee for a twenty-four-hour pass shall be \$50 per pass.

I. For customers who have contracted for more than 20 but less then 40 spaces, the monthly fee for a twenty-four-hour pass shall be \$65 per pass.

Monthly evening parking garage pass for employees working downtown will be \$20 per month, between the hours of 3:30 p.m. and 5:00 a.m. Pay stubs are required to qualify for this rate, which will be audited on a quarterly basis by the Dirert-Or of Finance, or their designee. The parking pass will expire after 90 days, at which time the pass holder will have to reapi-- ;

M. For garage customers violating the terms of monthly parking, which results in the turning off of a customer's card, the e · will be \$10 to reactivate the card.
