## **ORDINANCE NO. 814-2020**

AN ORDINANCE OF THE TOWNSHIP OF EAST PENNSBORO, CUMBERLAND COUNTY, PENNSYLVANIA AMENDING CHAPTER 15, THE MOTOR VEHICLES AND TRAFFIC ORDINANCE OF EAST PENNSBORO TOWNSHIP BY AMENDING \$15-201 MAXMIUM SPEED LIMITS ESTABLISHED ON CERTAIN STREETS; AMENDING §15-205 TRAFFIC SIGNALS AT CERTAIN LOCATIONS; AMENDING §15-207 ONE-WAY ROADWAYS ESTABLISHED: AMENDING §15-208 TURNING AT CERTAIN INTERSECTIONS PROHIBITED OR RESTRICTED; **AMENDING** \$15-211 THROUGH HIGHWAYS ESTABLISHED; AMENDING §15-212 STOP INTERSECTIONS ESTABLISHED; AMENDING §15-301 VEHICLE WEIGHT LIMITS ESTABLISHED ON CERTAIN STREETS AND BRIDGES; AMENDING §15-402 PARKING PROHIBITED AT ALL TIMES IN CERTAIN LOCATIONS; AMENDING §15-409 RESIDENTIAL PERMIT PARKING, ESTABLISHING §15-413 PARKING PROHIBITED FROM OBSTRUCTING MAILBOXES.

**SECTION 9**: Section 15-409 [Residential Permit Parking] with regard to designation of residential parking areas of the Code of Ordinances of the Township of East Pennsboro is hereby amended to vacate and remove, in the proper alphabetical sequence, of the following entries therein:

**SECTION 10**: Part Four of Chapter Fifteen [General Parking Regulations] of the Code of Ordinances of the Township of East Pennsboro is hereby amended with the addition of the following entries therein:

## § 15-413. Parking Prohibited From Obstructing Mailbox.

- 1. It shall be unlawful to park in a way which obstructs access to a U.S. postal mailbox, located aside a public street, by parking within ten (10) feet of the mailbox.
- 2. Any person, firm or corporation who shall violate this section, upon conviction thereof, shall be sentenced to pay a fine not exceeding \$100.00 for the first offense; and a fine not to exceed \$300.00 upon any subsequent offense.
- 3. The vehicle may be towed at the owner's expense at a second or subsequent offense pursuant to §15-801 of this ordinance.

## §15-414. Penalties:

Any person who violates any provision of this Part, upon conviction, shall be sentenced to pay a fine of not more than \$50 and costs. Provided, it shall be the duty of the police officers and of parking enforcement personnel of the Township to report to the appropriate official all violations of any provision of this Part indicating, in each case, the section violated; the license number of the vehicle involved in the violation; the location where the violation took place; and any other facts that might be necessary in order to secure a clear understanding of the circumstances attending the violation. The police officer or other person making the report shall also attach to or place upon every such vehicle a notice stating that the vehicle was parked in violation of this Part. The notice shall contain instructions to the owner or driver of the vehicle that if he will report to the office of the Chief of Police and pay the sum annotated

on said ticket within five days after the time of the notice, or place the sum annotated enclosed within the envelope provided and mail said envelope within five days after time of the notice, that act will save the violator from prosecution and from payment of the fine and costs prescribed in this section.

SECTION 11: All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 12**: In all other respects, Chapter 15 [Motor Vehicles and Traffic] of the Code of Ordinances of the Township of East Pennsboro shall remain as heretofore enacted, ordained and amended, which said Chapter, as amended, is hereby re-enacted in its entirety herein.
