AN ORDINANCE OF THE TOWNSHIP OF EAST PENNSBORO, CUMBERLAND COUNTY, PENNSYLVANIA AMENDING CHAPTER 15, THE MOTOR VEHICLES AND TRAFFIC ORDINANCE OF EAST PENNSBORO TOWNSHIP BY AMENDING §15-207 ONE-WAY ROADWAYS ESTABLISHED FOR 2ND STREET IN VILLAGE OF WEST FAIRVIEW BETWEEN ABOLITION STREET AND CLAY STREET; AMENDING §15-212 STOP INTERSECTIONS ESTABLISHED FOR FOXCROFT DRIVE (NORTH) AT BRENTWATER ROAD, KEMPER ALLEY AT NORTH HUMER STREET AND KEMPER ALLEY AT GIVLER AVEUE; AMENDING §15-402 PARKING PROHIBITED AT ALL TIMES IN CERTAIN LOCATIONS ON 2nd STREET IN VILLAGE OF WEST FAIRVIEW BETWEEN CLAY STREET AND ABOLITION STREET.

BE IT ENACTED AND ORDAINED by the Board of Commissioners of the Township of East Pennsboro, Cumberland County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

SECTION 1: Section 15-207 [One-way Roadways Established] of the Code of Ordinances of the Township of East Pennsboro is hereby amended by the insertion, in the proper alphabetical sequence, of the following entries therein:

SECTION 2: Section 15-212 [Stop Intersections Established] of the Code of Ordinances of the Township of East Pennsboro is hereby amended by the insertion of the following entries therein:

SECTION 3: Section 15-402 [Parking Prohibited at All Times in Certain Locations] of the Code of Ordinances of the Township of East Pennsboro is hereby amended by the vacating of the following entries therein:

Street	Side	Between
2nd Street (VoWF)	East	Clay Street and Abolition Street

SECTION 4: All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 5: In all other respects, Chapter 15 [Motor Vehicles and Traffic] of the Code of Ordinances of the Township of East Pennsboro shall remain as heretofore enacted, ordained and amended, which said Chapter, as amended, is hereby re-enacted in its entirety herein.

SECTION 6: Effective Date. This ordinance shall be effective upon enactment.
