

ORDINANCE NO. 798 -2017

AN ORDINANCE OF THE TOWNSHIP OF EAST PENNSBORO, CUMBERLAND COUNTY, PENNSYLVANIA AMENDING AND REVISING ORDINANCE §757-2009, CHAPTER 15, MOTOR VEHICLES AND TRAFFIC, PART 9 SNOW AND ICE EMERGENCY §15-903 SNOW EMERGENCY ROUTES DESIGNATED, BY ADDING ABOLITION STREET BETWEEN STATE STREET AND THIRD STREET IN THE VILLAGE OF WEST FAIRVIEW; MODIFYING ACRI ROAD TO INCLUDE THE ENTIRE LENGTH; ADDING BRIDGE ROAD TO INCLUDE THE ENTIRE LENGTH; MODIFYING CREEKSID DRIVE TO BETWEEN MAGARO ROAD AND STATE STREET; ADDING EAST PENN DRIVE TO INCLUDE THE ENTIRE LENGTH; REMOVING OYSTER MILL ROAD; MODIFYING SALT ROAD TO BETWEEN VALLEY ROAD AND EAST PENN DRIVE; ADDING STATE STREET IN THE VILLAGE OF WEST FAIRVIEW BETWEEN S. ENOLA DRIVE AND ROUTES 11 AND 15; AND ADDING WERTZVILLE ROAD TO INCLUDE THE ENTIRE LENGTH.

IT IS HEREBY ENACTED AND ORDAINED by the Board of Commissioners of East Pennsboro, Cumberland County, Pennsylvania, and for the preservation of the health, safety and welfare of the inhabitants of this Township the following amendments to the Code of Ordinances of the Township of East Pennsboro regarding the Snow and Ice Emergency Ordinance as follows:

**SECTION 1:** Section 15-903 [Snow Emergency Routes Designations] of Part 9 [Snow and Ice Emergency] of Chapter 15 [Motor Vehicles and Traffic] of the Code of Ordinances of the Township of East Pennsboro is hereby amended by the insertion, in proper alphabetical sequence, of the following entries therein:

<b>Street</b>	<b>Between</b>
Abolition Street	State Street and Third Street (VoWF)
Acri Road	Entire Length
Bridge Road	Entire length
Creekside Drive	Magaro Road and State Street
East Penn Drive	Entire length
Salt Road	Valley Road and East Penn Drive
State Street	S. Enola Drive and Routes 11 and 15
Wertzville Road	Entire length

Further, the designation of Oyster Mill Road as a Snow Emergency Route is hereby vacated, rescinded, and repealed in its entirety

**SECTION 2:** All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** If any section, subsection, sentence, clause, phrase or word of this Ordinance is for any reason held illegal or invalid by any court of competent jurisdiction, such provision shall be deemed a separate, distinct and independent provision, and such holding shall not render the remainder of the amendments to this Chapter invalid.

**SECTION 4:** In all other respects, Chapter 15 [Motor Vehicles and Traffic] of the Code of Ordinances of the Township of East Pennsboro shall remain as heretofore enacted, ordained and amended, which said Chapter, as amended, is hereby re-enacted in its entirety herein.


This Ordinance shall become effective immediately.
