AN ORDINANCE AMENDING CHAPTER 7 OF THE BOROUGH CODE OF THE BOROUGH OF EAST NEWARK IN THE COUNTY OF HUDSON, STATE OF NEW JERSEY TITLED "TRAFFIC", SPECIFICALLY BY AMENDING SECTION 7-40.7 TITLED "PARKING LOT, RESIDENT PARKING" TO ADJUST FEES CONCERNING PARKING IN THE BOROUGH OF EAST NEWARK

Section 1.

c. Parking Fees.

[Amended 3-13-2019 by Ord. No. 02-2019; 12-9-2020 by Ord. No. 16-2020]

1. There is a \$65 - \$250 fee, per vehicle, for parking in the following lots:
 - Searing Avenue Lot
 - John Street Lot 1
 - John Street Lot 2
 - Veterans Lot
 - Central Avenue Lot
 - Passaic Avenue Lot
 - Valley National Bank Lot
2. There is a \$150 - \$350 fee, per vehicle, for parking in the Passaic Avenue Lot for commercial vehicles. Commercial vehicles shall be defined pursuant to Borough Ordinance 13-06 (Subsection 7-8.9).
3. Failure to pay the parking fee by the 10th of the month shall result in a \$25 late fee for the first offense and \$50 for the second offense, including forfeiture of parking privileges.

Section 3.


This ordinance shall take effect after its final passage by the Borough Council and approval by the Mayor at the time and manner provided for and required by law.




