AN ORDINANCE AMENDING CHAPTER 7 OF THE BOROUGH CODE OF THE BOROUGH OF EAST NEWARK IN THE COUNTY OF HUDSON, STATE OF NEW JERSEY TITLED "TRAFFIC", SPECIFICALLY BY AMENDING SECTION 7-8.10 TITLED "RESIDENTIAL PERMIT PARKING" TO ALLOW FOR 24 HOUR RESIDENTIAL PARKING ON THE STREETS OF THE BOROUGH OF EAST NEWARK THAT PERMIT TIMED PARKING.

**Section 1.**

**7-8.10 Residential Permit Parking.**

(1985 Code § 7-13.1; Ord. No. 06-16; Ord. No. 16-16; Ord. No. 14-2020)

No person shall park a vehicle on streets or parts of streets as described within the following sections unless an appropriate and current parking permit as issued by the Borough of East Newark is displayed on the vehicle for those streets or parts of streets as described or listed within the following sections.

Residential Parking Zone A. There is hereby established a Residential Parking Zone A. The zone shall consist of that area set forth on the attached map and includes the following streets:

Residents of Residential Parking Zone A that have registered their vehicle pursuant to the Residential Parking Program Ordinance, prior to the creation of the Residential Parking Zone A, are hereby grandfathered in and may park within the Residential Parking Zone A, only on the street on which they reside within the Residential Parking Zone A.

- 1. Residents residing in the Residential Parking Zone A must establish they have no off-street parking available before being eligible to register for residential parking.
2. Residential Parking Zone B. All other Borough streets not identified as part of Residential Parking Zone A are included in Residential Parking Zone B.
3. Parking in Residential Zone A and Residential Zone B shall be 24 Hours for all Borough residents who obtain a Borough parking permit and non-Borough residents. Unless otherwise designated in this Chapter; parking for non-Borough residents on streets within Residential Zone A and Residential Zone B shall be permitted, but only for a maximum of 2 hours between the hours of 8:00 a.m. and 6:00 p.m..

Section 2.

Inconsistent Ordinances

Section 3.

This ordinance shall take effect after its final passage by the Borough Council and approval by the Mayor at the time and manner provided for and required by law.
