## BOROUGH OF EAST NEWARK COUNTY OF HUDSON, STATE OF NEW JERSEY

AN ORDINANCE AMENDING CHAPTER 2 OF THE BOROUGH CODE OF THE BOROUGH OF EAST NEWARK IN THE COUNTY OF HUDSON, STATE OF NEW JERSEY TITLED "ADMINISTRATION", SPECIFICALLY BY AMENDING ARTICLE VII TITLED "ADMINISTRATIVE FEES" AND SECTION 2-50 TITLED "FEES CHARGED FOR MUNICIPAL SERVICES" BY ADDING AN ADDITIONAL SECTION AND/OR SUBSECTION AUTHORIZING FEES TO BE CHARGED FOR RECREATIONAL PROGRAMS.

## Section 1.

§ 2-50. FEES CHARGED FOR MUNICIPAL SERVICES.

§ 2-50.1. All Borough Offices.

- c. Recreational Program Fees.
  - 1. There shall be a fee to be charged to members of the public for the use and participation in the public parks, recreational facilities and areas and the recreational programs of the Borough of East Newark in an amount of no less than \$10 and no more than \$500 as determined by the Borough Administrator or his or her designee.
  - 2. For the purposes of this section, recreational programs and events shall include, but not be limited to:
    - (a) Sports Programs (youth and adult);
    - (b) Health, exercise and wellness programs (youth and adult);
    - (c) Art and dance (youth and adult):
    - (d) Team sporting events (youth and adult):
    - (e) Fairs, conferences and activities deemed by the Borough to have a recreational purpose; and
    - (f) Rentals of Borough property for recreational programs and events.

3. Within the range established in subsection (c)(1) above, it is recommended that the Mayor and Borough Council establish by resolution on an annual basis, or more often as may be required a fee schedule for various recreational programs and events. Should the Mayor and Borough Council elect to establish a schedule of fees by resolution; it shall be the responsibility of the Borough Administrator or his or her designee to recommend a schedule of fees to the Mayor and Borough Council.
