ORDINANCE NO. 247 OF 2021

AN ORDINANCE OF EDGMONT TOWNSHIP, DELAWARE COUNTY, PENNSYLVANIA, ESTABLISHING ADDITIONAL STOP INTERSECTIONS ON TOWNSHIP ROADS WITHIN THE RUNNYMEADE FARMS PRD IN CONNECTION WITH THE DEVELOPMENT OF PHASE 7 THEREOF AND PROVIDING FOR PENALTIES FOR THE VIOLATION THEREOF.

WHEREAS, the Board of Supervisors (the "Board") of Edgmont Township (the "Township") by official Resolution No. 25 of 2020 ("Resolution 25") approved the final phase of the Runnymeade Farms PRD known as Phase 7; and

WHEREAS, the Board, in order to advance the health, safety and welfare of the residents of the Runnymeade Farms PRD, including Phase 7, as well as those traveling the interior roads of the Runnymeade Farms PRD, imposed by the adoption of Resolution 25, certain traffic control improvements, among them being Condition No. 3; and

WHEREAS, Condition No. 3 of Resolution 25, required among other things, the implementation *traffic improvements...as outlined in the April 25, 2019 Traffic Planning and Design Memorandum and associated undated aerial plan* (the "**TPD Memo**");

WHEREAS, the TPD Memo recommended, among other improvements, that all-way stop controls be installed at the following intersections:

Runnymeade Drive and Charter Oak Drive Runnymeade Drive and Sawgrass Lane Runnymeade Drive and Riders Run Road Ridgeview Road and Riders Run Road¹

WHEREAS, Section 1609 (a) (6) of the Pennsylvania Vehicle Code [75 P.S. § 6109 (a) (6)], authorizes the Board to designate any intersection or junction of roadways as a stop or yield intersection or junction.

NOW THEREFORE, **IT IS HEREBY ENACTED AND ORDAINED** by the Board of Supervisors of the Township of Edgmont, Delaware County, Pennsylvania, as follows:

Section 1. Stops signs shall be located, erected and maintained by the Township at the following intersections which are on Township owned roads:

- <u>Section 2.</u> Stop signs, mounting posts and location shall conform to all current Pennsylvania Department of Transportation regulations.
- <u>Section 3</u>. Violations of this Ordinance shall be enforced in accordance with the applicable fine and penalty provisions of the Pennsylvania Vehicle Code [75 P.S. § 101, et seq.].
- <u>Section 4.</u> The provisions of the Ordinance shall be in addition to and not in replacement of any other Township Ordinance establishing stop signs within the Township.
- Section 5. The provisions of this Ordinance are severable, and if any section, sentence, clause, part or provision hereof shall be held to be illegal, invalid or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect or impair the remaining sections, sentences, clauses, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Board of Supervisors that this Ordinance would have been enacted if such illegal, invalid or unconstitutional section, sentence, clause, part or provision had not been included herein.
- **Section 6.** This Ordinance shall take effect and be in force five (5) days after its enactment by the Board of Supervisors, and shall thereafter be submitted by the Township Manager for codification in and as a part of the official Edgmont Township Code.
