

Egg Harbor Township

Ordinance No. 19

2024

An ordinance to amend Chapter 213 of the Township Code entitled “Vehicles and Traffic”, specifically Section 213-23

WHEREAS, N.J.S.A. 39:4-8, N.J.S.A. 39:4-197 and N.J.S.A. 39:4-140 authorize a Municipality, by Ordinance, to regulate traffic and vehicles on municipal streets and portions thereof; and

WHEREAS, a recommendation has been made by the Township of Egg Harbor Engineer and by the Traffic Safety Supervisor of the Egg Harbor Township Police Department to regulate the flow of traffic by creating four way intersections at West Jersey Avenue and Ridge Avenue; West Jersey Avenue and Cates Road; and Reega Avenue and Cates Road in the interest of public safety, and

WHEREAS, the Governing Body of the Township of Egg Harbor is permitted to adopt said ordinance without the approval of the Commissioner of Transportation pursuant to N.J.S.A. 39:4-8, N.J.S.A. 39:4-197, and N.J.S.A. 39:4-140; and

WHEREAS, the Township Engineer has submitted and certified all of the legislative requirements, pursuant to N.J.S.A. 39:4-8(b) and that the criteria as set forth by the New Jersey Department of Transportation, Bureau of Traffic Engineering and Investigations has been met; and

BE IT ORDAINED, by the Township Committee for the Township of Egg Harbor, County of Atlantic and State of New Jersey that:

SECTION 1 Chapter 213-23 Four-way stop intersections of the Code of the Township of Egg Harbor, **Section 213-23** is hereby amended by adding the following intersections:

Intersections	Stop Sign On
West Jersey Avenue and Ridge Avenue (4-way)	West Jersey Avenue (both sides at Intersection with Ridge Ave) Ridge Avenue (both sides at Intersection with West Jersey Avenue)
West Jersey Avenue and Cates Road (4-way)	West Jersey Avenue (both sides at Intersection with Cates Road) Cates Road (both sides at Intersection with West Jersey Avenue)
Reega Avenue and Cates Road (4 Way)	Reega Avenue (both sides at Intersection with Cates Road) Cates Road (both sides at Intersection with Reega Avenue)

SECTION 2: All ordinances and parts of Ordinances inconsistent with the provisions of this ordinance are, to the extent of such inconsistency, hereby repealed.

SECTION 3: If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by a Court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This Ordinance shall take effect upon final passage, adoption and publication in the manner prescribed by law.
