

Egg Harbor Township

Ordinance No. 14

2026

An ordinance amending Chapter 64 of the Code of the Township of Egg Harbor entitled “Alcoholic Beverages”, specifically subsection 64-3 (D.) entitled “Licenses”

WHEREAS, the Township of Egg Harbor, County of Atlantic, State of New Jersey, previously issued a total of twenty-seven (27) Plenary Retail Consumption Licenses; and

WHEREAS, Plenary Retail Consumption License No. 0108-33-005-008, previously issued to Gaspare’s Inc., has permanently lapsed and ceased to exist due to the licensee’s failure to comply with statutory and regulatory requirements, as confirmed by Resolution No. 219 of 2026, adopted on May 20, 2026; and

WHEREAS, as a result of the permanent lapse of said license, the Township of Egg Harbor is no longer eligible to issue a twenty-seventh (27th) Plenary Retail Consumption License; and

WHEREAS, the Township Committee finds it necessary and appropriate to amend the Township Code to reflect this reduction in the number of available Plenary Retail Consumption Licenses;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Egg Harbor, County of Atlantic, State of New Jersey, that Chapter 64, subsection 3 (D.) of the Code of the Township of Egg Harbor is hereby amended as follows:

SECTION 1: Chapter 64 of the Code of the Township of Egg Harbor, Section 64-3 (D.) is hereby deleted in its entirety and replaced as follows:

- D. License fees. The annual license fees, type and maximum number of licenses for the sale or distribution of alcoholic beverages in the Township shall be as follows:

Type of License	Annual Fee	No. of Licenses
Plenary retail consumption	\$2,500	26
Plenary retail distribution	\$2,500	6
Club	\$188	75

SECTION 2: All ordinances and parts of Ordinances inconsistent with the provisions of this ordinance are, to the extent of such inconsistency, hereby repealed.

SECTION 3: Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the remaining portions of this ordinance.

SECTION 4. This Ordinance shall become effective immediately upon final adoption and publication according to law.

NOTICE IS HEREBY GIVEN THAT THE FOREGOING ORDINANCE WAS INTRODUCED AT A MEETING OF THE TOWNSHIP COMMITTEE OF EGG HARBOR TOWNSHIP, IN THE COUNTY OF ATLANTIC, STATE OF NEW JERSEY, HELD JUNE 17, 2026, AND WILL BE FURTHER CONSIDERED FOR FINAL PASSAGE AFTER A PUBLIC HEARING THEREON AT A REGULAR MEETING OF SAID TOWNSHIP COMMITTEE TO BE HELD IN THE TOWNSHIP HALL, IN SAID TOWNSHIP ON JULY 1, 2026.
