## LOCAL LAW 2023 - 5 FURTHER AMENDING CHAPTER 265 ("Zoning"), OF THE CODE OF THE TOWN OF ELBRIDGE

**BE IT ORDAINED AND ENACTED** by the Town Board of the Town of Elbridge, County of Onondaga, State of New York, as follows:

Section 1. That Chapter 265-14, entitled "Business (B1) District", Paragraph (8) of the Code of the Town of Elbridge is amended as follows: §265-14 Business (B1) District

- (8) Multi-family dwelling after approval of the site plan thereof by the Planning Board pursuant to §265-80 of this chapter. When considering the site plan for the multi-family dwelling, the Planning Board shall satisfy itself that the following conditions exists:
- (a) The lot upon which the multi-family dwelling is being proposed in more appropriate for a multi-family dwelling than a business based on the location, proximity to other residential homes, configuration of the lot, access for motor vehicles, and the general topography of the lot.

Section 2. This local law shall take effect upon the filing with the Secretary of State.
