AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF EL RENO, OKLAHOMA; CODE CHAPTER THREE HUNDRED SIXTY-ONE (361), SECTION TEN (10); SECTION FIFTY-SEVEN (57); SECTION SIXTY-EIGHT (68); HAVING TO DO WITH DEFINITIONS AND PERMITTED USES; AMENDING AND REPEALING CONFLICTING SECTIONS; PROVIDING FOR SEVERABILITY, AND DECLARING AN EMERGENCY.

SECTION 1: That Section 361-10 of the El Reno Code of Ordinances is hereby amended by removing the following definitions:

§ 361-10. Definitions.

- Automobile Wrecking Yard
- Garage, Parking
- Garage, Public

SECTION 2: That Section 361-57 of the El Reno Code of Ordinances is hereby amended by removing the following uses from the Table of Permitted Uses in Commercial Districts:

- Automobile parking or storage, as principal use
- Cold storage plant
- Food locker plant
- Garage or parking for commercial or public utility vehicles
- Marine and boat rental, repair, sales
- Packing or crating service
- Parking (automobile) or storage as a principal use
- Parking for commercial or public utility vehicles
- Storage, mini-warehousing
- Warehousing, inside storage only
- Warehousing, outside storage
- Wholesale establishment, stock limited to floor samples
- Wholesale establishment with stocks not limited to floor samples

SECTION 3: That Section 361-68 of the El Reno Code of Ordinances is hereby amended by removing the following uses from the Table of Permitted Uses:

- Automobile parking or storage, as a principal use
- Boat rental or storage
- Bus garaging and equipment maintenance
- Cold storage plant
- Farm products, NEC, wholesales or public warehousing
- Freight forwarding service
- Packing and crating service
- Warehousing, NEC other than warehousing accessory to another permitted use
- Wholesaling, NEC

• Wholesaling, or public warehousing of farm products NEC, food NEC, grain, hides, skins, raw furs, livestock, petroleum products (bulk station or terminal), scrap or waste materials

SECTION 4: That the permitted uses in all districts are set forth in the table below. Where the letter "X" appears on the line of a permitted use and in the column of a district, the listed use is permitted in that district, subject to the general provisions of this chapter. Where the letter "P" appears instead of the letter "X," this use is permitted subject to acquiring a conditional use permit as set forth in Article XXII. If a use is not found in this table, then the uses listed in Section 361-39, Section 361-43, 53, Section 361-57, Section 361-61, Section 361-68, Section 361-81, Section 361-111, and Section 361-114 shall prevail.

SECTION 5: All former ordinances or parts of ordinances conflicting or inconsistent with the provisions of this ordinance are hereby repealed.

SECTION 6: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance, or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity of effectiveness of the remaining portions of this ordinance or any part thereof.

SECTION 7: It being immediately necessary for the preservation of the public health, peace, and safety of the City of El Reno and the inhabitants thereof, an emergency is hereby declared to exist by reason whereof, this Ordinance shall be in full force and effect from and after its passage and approval, as provided by law.
